Slower economy seen for Michigan

Michigan's economic prospects for the second half of 2023 mirror predictions for the rest of the country – slower job growth and a slower economy are com-

But that future is building on a strong present, and a recession that some economists are predicting – if one ever comes to pass – should be mild. That's the word from the Construction Association of Michigan, which issued a "Mid-Year Economic Forecast and State of the Industry" on June 20.

In a forecast presented by Elliot Eisenberg, Ph.D., chief economist for consulting agency GraphsandLaughs LLC, he said he expects a recession, but it will be one of the "milder recessions you just don't recall" compared to some "real doozy" past recessions. He said several economic indicators are still bolstering the economy - auto and home sales are still good, and inflation has backed off. But more interest rate hikes are expected by the Federal Reserve, and consumer confidence is

On the positive side, CAM said, "new construction trends (post COVID-19) show promise, particularly in nonresidential projects." Construction activity is up about 25 percent compared to this time last year. CAM said at the beginning of 2023, Michigan and its largest counties and cities had only spent about \$2.2 billion of the \$10 billion in federal stimulus that was awarded the state.

Overall, Eisenberg said everyone should be prepared to see the economy weaken over the second half of 2023 as job growth slows down, CAM reported.

Detroit Labor Day parade hits reset

The Detroit Labor Day Parade is back, but it won't be the same route as in years past.

The parade had taken a pandemic-related hiatus, and it will be held this year for the first time since 2019.

This year, the march will start at 9 a.m. at Michigan Avenue and Sixth Street (at the Lodge Freeway overpass) and proceed east toward the Ford Motor Co. Michigan Central train station. Then the march will proceed back to Dean Savage Park at Porter Street and Trumbull, next to IBEW Local 58, for a celebration.

Other Labor Day celebrations around Michigan will be held, as usual. There will be more details to come, but mark your calendar for Monday, Sept. 4.

Michigan road money comes up short

Fix the damn roads? An \$82 billion state budget signed by Gov. Gretchen Whitmer on July 31 included an 8.1 percent increase for the Michigan De-

partment of Transportation. But the new \$6.6 billion MDOT budget only assigned \$497 million in new money to the agency, despite the Michigan Infrastructure and Transportaiton Association's claim that the state should be spending an additional \$3.9 billion annually to properly fix the roads.

New at the Soo: heavy equipment dominates new lock construction

SAULT STE. MARIE -While 1,000-foot-long freighters glide by their worksites, tradespeople – many of them operating cranes and other heavy equipment – have been busy this summer getting the Soo Locks ready for its biggest upgrade in nearly half a century.

The U.S. Army Corps of Engineers Detroit District, which has jurisdiction over the locks, said in June that the remains on schedule as ma-

The new lock would twin the existing Poe Lock (completed in 1968) and allow the movement of longest freighters sailing the Great Lakes. The work is being undertaken by joint ventures Kokosing-Alberici (upstream approach walls, Phase 2), and Kokosing, Alberici, Traylor (new lock, Phase 3).

The Soo Locks are situated on the St. Marys River at Sault Ste. Marie, Michigan, and allow "New Lock at the Soo project vessels to transit the 21-foot elevation change from Lake Superior

Teamsters reach accord with UPS **Landmark contract** could be template for union expansion

WASHINGTON (PAI) – The Teamsters claimed a big win on July 25 when, within hours of bargaining restarting for the first time in three weeks, UPS agreed to a five-year tentative contract with the union.

The pact gives workers substantial raises, eliminates many part-time jobs by raising the positions, and the workers in them, to full-time, and effectively kills the hated two-tier wage system at the nation's largest package delivery company, which employs 340,000 Teamsters.

"We've changed the game," union President Sean O'Brien exulted. A UPS strike would have had an enormous effect on the U.S. economy, with the Teamsters in brown uniforms moving about 37 percent of the nation's parcel

would have forced the workers to strike and cost their own company hundreds of millions of dollars a

day. Had the union been forced to walk, it would have been the largest private-sector strike against a single company in U.S. history.

Before the July 25 session, United Parcel Service honchos had walked out of bargaining at 4:15 a.m. on July 5 after presenting what O'Brien called "an insulting" wage offer. "Rankand-file UPS Teamsters sacrificed everything to get this country through a pandemic and enabled UPS to reap record-setting profits," O'Brien said.

"The union went into this fight committed to winning for our members. We demanded the best contract in the history of UPS, and we got it. UPS has put \$30 billion in new money on the table as a direct result of these negotiations. It will go into the pockets of our members, full-time and part-time."

The future prospects for U.S. ated General Contractors' chief construction activity are a bit economist, on July 21. "But with muddled, but there's little doubt an industry unemployment rate about the current employment situation. This summer it's as hot as the desert Southwest.

Construction employment in U.S. construction was up 2.8 percent year-over-year at the end of the first half of 2023, defying the higher interest rate environment, lingering supply chain challenges, increased material costs and some indecision among decisionmakers about the near-term future of the economy.

their projects." Between June 2022 and June 2023, 45 states added construction jobs, while industry employment declined in five states – but even those employment declines were all under 2 percent. Michigan has been among the leading construction job creating states in the nation in recent years. And numbers for the end

of June, released July 21, didn't buck that trend. Michigan saw a 4.4 percent increase in construction jobs from June 2022 to June 2023 (No. 15 percentage-wise among the states). That blistering pace netted a total of 8,000 new construction jobs during that

Michigan now has 191,800 construction workers employed -9.2 percent more than the 177,800 workers who were employed just before Covid hit in February

An in terms of overall employment, Michigan's 3.6 percent unemployment rate for June is among its lowest since the U.S. Bureau of Labor Statistics (BLS) started keeping monthly state rates in 1976. Still, with a strong national jobs picture, Michigan's jobless rate was the 12th highest among the 50 states.

A.C. and union organizing

Ever since he prevailed over the incumbent regime in last year's Teamster presidential election, General President Sean O'Brien has been clear that the union had a twofold goal in its bargaining with UPS, where 340,000 Teamsters were employed. The Teamsters were out not just to win sizable gains for their members, but to make those gains so significant that they'd bolster the union's prospects for its next, decidedly herculean, venture: unionizing Amazon.

Did the agreement that the union reached with UPS on July 26 accomplish that goal? Could be – but chiefly because of some provisions that haven't been widely reported.

The wage increases that UPS felt compelled to agree to were real, but some reporting has indicated that at least some members were expecting, or at least hoping for, more. (UPS-employed Teamsters will vote on the proposed contract this month). The starting hourly wage for part-time employees, who constitute roughly half of the company's unionized workforce, will rise from \$16.25 to \$21 - a major hike, but less than the \$25 for which one group of members was advocating.

But I don't think the wage increases are really the key to convincing Amazon's hundreds of thousands of warehouse and trucking employees to sign up with the Teamsters. The wage differential between UPS and Amazon employees working equivalent jobs will have some impact, but Amazon has shown a willingness to raise wages when it needs to.

But then, its entire business model is based on attracting workers because it may pay more than the local competition, and, knowing it can always hire their successors, compelling them to quit in less than a year because working conditions are so onerous and exhausting. Which is why some other, non-wage-related provisions of the proposed UPS contract will likely prove especially compelling to Amazon employees.

The first is the company's agreement to air-condition its trucks, which one driver memorably compared to microwave ovens. The heat in Amazon warehouses has long made work there gratuitously uncomfortable and frequently dangerous, so the Teamsters' ability to compel UPS to invest in AC can only bolster the union's cred.

More significant still is the contract's elimination of the company's surveillance cameras trained on the drivers, whose every move had been monitored by UPS supervisors. That, I'd think, would hold particular importance in Amazon warehouses, where workers' every step, every pause, and overall speed rates are continually monitored and recorded by Amazon's high-tech system of cameras – a Yeatsian rough beast with "a gaze blank and pitiless as the sun."

Amazon's workers are subjected to the same dystopian surveillance that official America decries when China's government inflicts it on its citizenry. But now that the same technological capacity enables American employers to subject their workers to this dehumanizing and abusive surveillance, it takes a powerful union to free such workers from this 21st-Century Taylorism (scientific

(California has enacted a law banning companies from using metrics based on such surveillance to punish workers, but it doesn't ban the surveillance itself.)

I suspect that this feature of the UPS contract will be one of the Teamsters' major selling points as they hope to roll the union

"Since resuming major construction this season, the Phase 2 contractor has placed 13 concrete caps, bringing the total caps placed to 68 and preparation for placement of new steel sheets, steel posts and concrete panel wall are in progress," New Lock Senior Project Manager Mollie Mahoney said. "The Phase 3 contractor plans to focus on demolition of aging structures, extensive electrical work, bridge construction, and coffer dam construction to allow for dewatering."

of Engineers, included deepening the upstream approach to the New Lock from 24 feet to 30 feet deep so modern vessels can approach the New Lock at the Soo and concluded in August 2022, under budget and ahead of schedule.

Ongoing Phase 2 includes rehabilitating the upstream approach walls to stabilize the existing approach walls, allowing modern vessels to tie up and wait their turn to pass through the new lock. The estimated completion date for Phase 2 is summer 2024.

Kokosing, headquartered in Ohio, said the work to rehabili-

Phase 1, said the Army Corps tate the upstream approach walls consists of installing more than a mile of new approach walls in a newly deepened channel of at least 30 feet in depth. The new approach walls are a combination of sheet pile cells, z-pile walls, and soldier piles with concrete lagging all of which are topped by reinforced concrete cap slabs with integrated mooring bits, lighting, and fendering.

"Construction of the walls requires over 60,000 cubic yards of concrete which will be produced in an onsite batch plant operated by the joint venture team. The project also requires placement of 30,000 cubic yards of underwater tremie concrete under strict mass concrete thermal control parameters. The project site is inaccessible by vehicle so all material and labor must be ferried across the very active federal navigation channel or delivered directly by lake freighter," said a description by

Phase 3, the Corps said, includes demolishing the existing Sabin Lock, excavation of bedrock, constructing the New Lock at the Soo chamber walls and floor, fabrication and installation of miter gates, installation of mechanical and electrical systems, installation of the innovative hands-free mooring system, rehabilitating downstream approach walls and constructing a new pump well. The estimated completion date for Phase 3 is summer 2030.

Last December, the U.S. Army Corps of Engineers said the total project cost had been reauthorized at \$3.2 billion.

The Soo Locks are seen as vital infrastructure, "and this critical node's reliability in the Great Lakes navigation system is essential to U.S. manufacturing and national security. An unscheduled Poe Lock outage would have significant impacts to the U.S. economy, especially the steel industry, according to a 2015 Department of Homeland Security study on impacts of an unexpected Soo Locks closure," the Army Corps said.

BUILDING MICHIGAN: The Champion Shaft-Rock House HISTORY IN THE MAKING By Marty Mulcah

FIRST ERECTED IN 1902 and then replaced with the present structure in 1909, the Champion No. 4 **Shaft-Rock House in** Painesville in the Upper Peninsula stands mostly unchanged since its hoist engine last pulled copper from the ground in 1967. Volunteers are working to rehabilitate the property. The structure served a copper mine shaft extending more than a mile underground.



The Upper Peninsula's rich mining heritage is difficult to support and maintain – with the region's remote locations, lack of funding, sparse population and long-abandoned, decrepit structures.

So praise and honor to the volunteers at the nonprofit Painesdale Mine & Shaft Inc., a group working to maintain the tangible history of the Champion Mining Co. and Copper Range Mining Co. by slowly resurrecting the long-abandoned and barely surviving Champion No. 4 Shaft-Rock House.

Located centrally in the heart of the Keweenaw Peninsula, the Painesdale community was at the heart of the U.P.'s Copper Country, a 100-squaremile belt of land that yielded more than 14 billion pounds of copper to miners from the 1840s until the 1960s, according to Michigan State University.


In June, Painesdale Mine & Shaft was named the newest Keweenaw Heritage Site, a registry of more than 20 partner sites that contain significant cultural or natural resources as part of Michigan's copper mining history.

"We are very excited to join the Heritage Site program," said Painesdale Mine & Shaft Inc. President Michael Prast. "This is something we have been working towards for years as we have grown as an operation. It is wonderful to officially be a part of the network of wonderful historic sites working to preserve and share the local copper mining history." Restoration efforts by the group at the site's Champion No. 4 Shaft-Rock House have been ongoing for the past

Says an historic sign at the site: "Having escaped the scrapper's torch a second time, this historic structure now must fight the destructive forces of nature. Little else remains of one of the Keweenaw's great mining companies, Copper Range Co., which was co-owned by William Paine, the founder of investment giant Paine-Webber. Of the mines that ran from Atlantic Mine to Painesdale, the Champion No. 4 before you is the only headframe still standing; it is also the oldest shaft-rock house remaining in the Keweenaw.

"Unique in its design, the crushing floor is less automated than later types. It was built in 1902 and enlarged to its

present form in 1906, times when hand labor and brute force moved mountains. The Champion No. 4 embodies the stories of thousands of men who passed through it as they headed to work in the mine below. It speaks of the men that lived and died blasting, tramming, hoisting, and crushing the copper rock that fed the area's economy. By preserving this structure, the story of those men, their sacrifices, their labors, and their accomplishments will also be preserved."

Last fall the Houghton County Historical Preservation Fund awarded a grant to the Painesdale group to stabilize and improve the stairs and walkways of the upper levels of the No. 4 shaft-rockhouse. Other restoration projects have taken place or are under way. The site is open for tours, go to https://painesdalemineshaft.com.

Today Painesdale is an unincorporated community (population 336) in Houghton County along M-26. A century ago, it was an archetypal company town, including some 200 workers' row houses, whose copper-producing heyday was between the years between 1900-1930. Some buildings and many ruins remain from the community, In addition to the No. 4 shaft-rock house, other buildings still standing or identifiable include: the mine captain's office, a hoist house, the D-shaft rock house, a train trestle, an oil house and a dry

"The Champion Mine consisted of four shafts in the town of Painesdale, south of Houghton," says *Mining Artifacts*. "The Champion Mining Co. was organized in 1899 and came under control of the Copper Range Consolidated Co. in 1901. By the 1930s the mine was working the 48th

level in No. 4 shaft, 4,800 feet from the surface on the incline. This shaft was later extended to the 56th level, approximately 5,500 feet from the surface on the incline." Shafts at the site were opened and closed over the years, and equipment was transferred among them to seek new ore deposits as the mine sunk to new depths.

The Evolution of Champion #4 Painesdale, Michigan on Copper Range.org described 1908-1917 as "the glory years" for the mine. "By this time at Champion almost all of the major construction is complete," the paper said, "functions are changing as production drives deeper into the mine. Shaft-Rock House #4 proved so productive, that in fact, stamp sands are dumped back into the shaft to support the mine."

Inflated copper prices helped keep the mine afloat during World War II, but by the end of the war, only a single shaft was operating – No. 4 - and it was limited to a single shift. The lack of economically retrievable copper, a long worker strike and corporate disinterest led to the closure of the mine in 1967.

The Champion mine was still useful after it was closed to retrieving copper. A large underground aquifer that incessantly seeped into one of the mine's lower levels is still used as a supply for a municipal water. Adams Twp. officials decided to utilize the flooded shaft, the aquifer and the existing structures to create a municipal water supply system.

"The shaft house, hoist house, and others facilitated the installation and maintenance of several underground pumps and other equipment for this new use," said Nailhed.com, a site that explores Michigan's abandoned structures.

(Continued from Page 1) rewards their labor, and doesn't require a single concession. This contract sets a new standard in the labor movement and raises the bar for all workers," he declared.

Said Bloomberg Law: "The Teamsters showed it's possible to regain ground that the union lost during the late 1980s through the Great Recession, creating the conditions for a spillover effect into other companies, business and labor observers say. That gives unions a new organizing argument as it battles automation and dwindling membership."

O'Brien previously said the Teamsters would also promote the new UPS pact, assuming its ratified in the one-Teamster-one-vote election from Aug. 3-22, as a reason Amazon warehouse workers and truckers should organize with the union, too.

In apparently winning, O'Brien and his running mate, Secretary-Treasurer Fred Zuckerman, kept the key campaign promise which carried their reform slate to victory in the 2020 one-Teamster-one-vote presidential race: A promise to UPS workers, who had their last contract imposed by then-President Jim Hoffa, of a new and generous pact.

The union's large bargaining committee, which included rank-and-file reps from the 176 Teamster locals with UPS members, unanimously endorsed the tentative agreement. Rank-and-file analysis and discussion of it will precede the balloting.

The union credited strong solidarity and strike preparation, plus increased militancy from rank-and-file members as factors prompting the firm's honchos to yield. Said negotiating committee member Brandy Harris of Local 174 in Seattle, a part-timer: "Our union was organized and we were relentless. We've hit every goal that UPS Teamster members wanted and asked for."

New York City Comptroller Brad Lander added another factor: Wall Street. A Teamsterpublished analysis shows institutional investment firms, such as JPMorgan Chase and Black Rock, own 72 percent of UPS stock, and Lander told Reuters they didn't want a strike.

"The vast, vast, vast majority of shareholders are eager to see a strike averted," he said. Lander is official investment adviser for city workers' retirement systems, which hold \$191.1 million in

Zuckerman said not only are there substantial raises, but "a full range of new protections for them on the job."

One protection, previously announced: Air conditioning in all new UPS vehicles starting Jan. 1, gradually replacing each car and truck in the fleet. All current vehicles immediately get two fans and air vents in their cargo compartments. Other contract details include:

•Raises of \$2.75 more per hour in 2023, and \$7.50 more per hour over the five years. The average top rate for full-time drivers will top out at \$49 hourly, up seven dollars.

•Current part-timers get an immediate hike from \$16.20 hourly to \$21, plus longevity increases of \$1.50 per hour. New part-timers will start at the \$21 rate, followed by a two-dollar hike and "market rate adjustments."

•So-called 22.4 drivers, all part-timers, would be immediately reclassified as full-time package car drivers, ending the two-tier wage system which saw them start at much lower rates. Their years as part-timers will be included in seniority rankings.

•"No more forced overtime on Teamster drivers' days off. Drivers would keep one of two work-week schedules and could not be forced into overtime on scheduled off-days.

•"UPS Teamster part-timers will have priority to perform all seasonal support work using their own vehicles with a locked-in eight-hour guarantee. For the first time, seasonal work will be contained to five weeks only from November-December."

•7,500 new full-time Teamster jobs and company commitment to fill 22,500 open positions, many of them to be taken by current part-timers.

"Just as the defeat of organized labor in Wisconsin by then-Gov. Scott Walker in 2011 cast a pall over the labor movement, a victory by the Teamsters over a company the size and scope of UPS demonstrates to workers that unions do matter - and can win. This in turn will increase the already widespread efforts of workers in places like Amazon and Starbucks but also in manufacturing and universities. In other words, we can expect to see the type of mutually supportive organizing activity that occurred in times past," wrote labor activist Frank Emspak.

LA Times business columnist Michael Hiltzik said with internal and external pressure on UPS to establish a contract, the negotiating playing field was more level for both sides.

"When labor fights are conducted fairly, both sides have a feel for what's at stake," wrote Hiltzek. "Unions have to balance their members' immediate and longer-term welfare, management is aware of the cost of work stoppage to its bottom line and the prospect of losing customers permanently.

"The fights haven't been fair since 1947, when Congress passed the ferociously anti-union Taft-Hartley Act over President Truman's veto and employers started to feel free to treat unions as enemies to be destroyed.

"The tentative settlement reached between the Teamsters and United Parcel Service may serve as a reminder of what can be achieved on a more level —if not entirely level — playing field.

Other employers, notably the Hollywood moguls trying to bluster their way through a strike by actors and writers and the management of fierce anti-union companies such as Starbucks, are well advised to pay attention."

ACCIDENTAL DEATH and DISMEMBERMENT IN-SURANCE FROM OUR INTERNATIONAL ASSOCIATION: Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to $\$7,500.0\overline{0}$. This benefit comes as a dues paying member of SMART International.

WEEKEND WORK ASSIGNMENTS: Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall prior to 3:00 pm on Friday.

WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work. If you fail to do so you could be written up on charges.

LAY-OFFS: All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list 14 days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven days to apply for S.U.B. benefits after lay-off.

LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay. Without lay off slips you cannot collect sub pay. It is the member's responsibility to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

S.U.B. BENEFITS: Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven (7) days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

OUT-OF-WORK LIST: You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register bi-annually: March 1 through March 20 and September 1 through September 20. If you fail to re-register you will be removed from

SHORT WORK WEEK SUB PAY: If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the beginning or the end of a layoff. You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for (Continued on Page 5)

judges. Attorneys Bieske and Alfonsi can often make a winning difference at the application stage. And, if an appeal is necessary they have won several hundred cases before a court date is even set.

Those denied can appeal on their own but statistics for many years reveal that those represented by attorneys win a much higher percentage of appeals. And attorneys who specialize in Social Security Disability cases win a much higher percentage yet.

In addition to practicing only Social Security disability law attorney Bieske has written a book for attorneys about the subject and has been interviewed on various television programs. Both attorney Bieske and Alfonsi have also been

interviewed on radio programs and have given speeches to many groups. Attorneys Bieske and Alfonsi offer free phone or office consultation. If they represent you, there will be no fee charged until after the case is won. The fee

DETROIT (PAI) - Citing a decade of burgeoning profits at Detroit's "Big 3" auto firms, new Auto Workers President Shawn Fain laid out the union's bargaining goals for new contracts with them, featuring substantial wage hikes, an end to the two-tier wage system, restoring cost-of-living raises – gone since 2008 – and health care for all.

"Profits at GM are soaring, profits at Stellantis are recordbreaking and profits at Ford are surging," Fain said in an August 2 Facebook video talk to UAW members, including the 150,000 combined who work for Ford, General Motors and Stellantis, formerly FiatChrysler.

A chart Fain posted and discussed showed GM with a second quarter profit of \$3.2 billion, Stellantis with a first half profit of \$12.1 billion and Ford's profits tripling in the second quarter to \$1.9 billion. Fain said the firms predict combined profits this year of \$25 billion.

"This comes on top of the \$250 billion in profits the Big 3 have made over the last 10 years," he noted. The UAW members toiling at those carmakers' plants deserve a much larger share of those dollars, the union says.

As for the hated two-tier wage system, which the federal government imposed on the UAW as a condition of rescuing GM and FiatChrysler, which went broke in the Great Recession, Fain declared: "The Teamsters recently ended tiers at UPS and we're going to end tiers at the Big 3."

The car companies' profits ticked the workers off, since the workers, not the corporate honchos, manufacture the cars, trucks and SUVs that yield the firms' sales and cash

"What have the Big 3 done with these staggering profits?" Fain asked. "Instead of rewarding workers who have made these profits possible, the Big 3

plowed billions into stock buyback schemes that artificially inflate the value of the companies' shares and further enrich executives in the top 1 percent. "That's billions of dollars that have been robbed from the workers."

The simple solution came in a blue-and-yellow sign Fain held up during his Facebook video: "Record profits mean record contracts." The current contract expires Sept. 14.

Had starting pay at the Detroit car companies kept pace with inflation, a chart Fain posted shows, it would now be \$28.68 an dollars, less than the \$19.60 in real dollars it was in 2007. "That's more than \$21,000 a

year that our members have been robbed of. That's a life-changing amount of money," said Fain. Other bargaining goals

include, but are not limited to, making all temp workers into permanent employees, reducing the workweek to 32 hours, and in cases of layoffs, inserting UAW autoworkers into community service jobs, at company expense, until the workers are called back.

Labor Department to union busters earning federal tax dollars: place checkmark here on the form

(Continued from Page 1) as one reason it still opposes the Protect The Right To Organize Act, labor's top legislative priority.

The new check box "promotes transparency for workers," said Office of Labor-Management Standards Director Jeffrey Freund in a DOL statement. "This will enable employees of federal contractors and subcontractors, and the public more broadly, to be informed about the indirect source of funding used to persuade or surveil them in connection with organizing and collective bargaining."

"Certain employers must file a Form LM-10 to report, among other activities, agreements with 'consultants'" and other spending "to persuade employees concerning their organizing and collective bargaining rights or to surveil the activities of employees and unions involved in a labor dispute with such employers," DOL's Federal Register notice says.

The more-common pattern is a firm wins a federal contract, and then uses part of the dollars it gains from that cash flow to pay the union-buster. That's what Avondale Shipyards outside of New Orleans, whose main customer then was the U.S. Navy, did to combat an AFL-CIO Metal Trades Department joint organizing drive there. Avondale's union-busting failed.

Nevertheless, firms pay a lot for union-busters, but recoup their losses by defeating organizing drives using the union-busters' advice, fair, foul or "this is what the law says, but penalties are light," wink-wink-nod-nod. DOL's rule would, in an Avondale case, show how much the union-buster got.

Estimates of corporate spending on union-busting started at "roughly \$340 million annually" according to an Economic Policy Institute study four years ago, and they have have risen since. They're now more than \$400 million in 2021, the last year for which figures are available.

Among firms that year, Amazon was the top spender on union-busters, at \$4.26 million – a figure which may be low, given its spendthrift campaign against the independent Amazon Labor Union. ALU organized Amazon's big Staten Island warehouse and has launched organizing drives elsewhere.



OSHA readies do-over on injury record-keeping

(Continued from Page 1) recordkeeping rule has the following requirements:

•Employers in high-hazard industries (including construction) with 100 or more workers will have to submit their Forms 300, 301 and 300A to OSHA electronically by March 2 each year. Currently, those employers are only required to submit their 300A.

•Employers in high-hazard industries with 20 or more workers will continue to submit only their Form 300A.

•Employers with 250 or more workers in any industry are required to submit their Form 300A to OSHA annually.

According to OSHA, the main purpose of the rule is to improve the collection and tracking of workplace illness and injury

data. This rule will provide the agency with more detailed information on millions of recordable injuries each year. This will allow federal OSHA to better analyze how workers are being injured on the job and use that information to identify employers or industries with abnormally high injury and illness rates.

For an agency with a chronic shortage of inspectors due to budget constraints, being able to better target its compliance and enforcement efforts where they are needed most could literally save workers' lives.

Impact on the construction industry. According to 2017 data from the Bureau of Labor Statistics, about 60 percent of construction firms have 50 or fewer workers, and another 14

percent have fewer than 100. That means many employers across the industry will be exempt from this rule and can continue to only make their Forms 300 and 301 data available if OSHA requests it, such as during a jobsite inspection.

For larger construction employers, the bigger impact from this recordkeeping rule will be part of federal OSHA's plan to make companies' aggregated injury and illness data publicly available online. This pulling back the curtain on companies' safety and health records has been the primary objection from employers and employer associations since the rule was first issued in 2016.

Making safety and health data publicly available should benefit unions, researchers, pub-

lic health advocates and other groups seeking to make the construction industry safer. It should also give large construction employers a benchmark to compare themselves to and give companies that put worker safety and health at the forefront a way to tout their safe work environment. On the other hand, construction contractors with poor safety records will soon risk seeing their name online on a list of the most dangerous jobsites.

Once it's available online, this information could quickly become a valuable tool for Laborers International Union district councils, local unions, organizing funds, LECET Funds and other LIUNA affiliates in their efforts to organize workers and show the safety difference between many union and non-union projects.

Hardhat employment is hot, hot hot; but the future's a bit hazy

jobless rates were New Hampshire and South Dakota, each 1.8 percent. So far this year, U.S. construction has added a monthly average of 15,000 jobs. In June, residential specialty trade contractors posted the largest monthly increase in employment (+10,000), followed by employment in heavy and civil engineering construction (+7,300), nonresidential building construction (+5,400) and residential building construction (+800).

Average construction hourly earnings are also up, rising 4.4 percent in June from 12 months earlier.

The strong employment picture belies some doubt about the future construction economy. While inflation among many construction-related inputs has come under control, there are questions about future pricing in other commodities. Inflation has also dropped to a more reassuring 3 percent level – but few economists are ready to fully proclaim victory over higher costs. And interest rates remained elevated.

That's all starting to create doubts among project financiers considering starting new construction projects.

"Construction starts are oscillating – up one month and down the next," said Richard Branch, chief economist for Dodge Construction Network. "The presence, or absence, of mega-projects is a key influencer in this trend. Nevertheless, high interest rates and tightening lending standards are leading to uncertainty among owners and developers, also creating hesitation among stakeholders, leading them to carefully assess whether projects will break ground. These conditions will persist through the remainder of the year – meaning little forward motion in construction starts."

In fact, total U.S. construction starts fell 9 percent in June from the month before, the Dodge Construction Network reported July 21. But the longer backward trend is more positive. For the 12 months ending June 2023, total construction starts were 9 percent higher than that of June 2022. Nonbuilding starts (usually infrastructure) were 34 percent higher during those 12 months, and nonresidential building starts gained 25 percent. However, on a 12-month rolling basis, residential starts posted a 17 percent decline

Dodge's "Momentum Index" for U.S. construction fell 2.5 percent in June. "A deceleration in institutional planning caused the Momentum Index to decrease in June," said Sarah Martin, associate director of forecasting for Dodge Construction Network. "Project activity in this segment pulled back from the robust highs of the last three months but continued to dwarf year-ago levels. In contrast, growth in the commercial segment may be fleeting, as the continued elevation in interest rates and increasingly tight lending standards weigh down the sector in the latter half of the year."


