Rare-earth metals mine eyed in U.P.

The mining industry and building trades jobs in the Upper Peninsula have traditionally gone hand in hand over the past 150 years, even as the extraction of new metals has evolved

Building trades workers have made careers out of the starting, servicing, rehabilitating and re-opening of U.P. mines - especially those that contain iron ore. Over the past decade, the ongoing extraction of nickel and copper deposits in Big Bay's Eagle Mine have proven to be of great value.

Now, U.S. steelmaker Cleveland Cliffs CEO Lourenco Goncalves has told investors that geological surveys in Michigan, U.P. and Minnesota show great promise for the extraction of rare-earth metals, which are valuable in the manufacture of high-tech products.

"The important thing is that they are there," said Goncalves on Oct. 20. "We found them there. And we want to make it viable. We really believe that we have potential there. And that it will be good for Michigan, for the Upper Peninsula, primarily. And there's even one site in Minnesota that we would go. It's not very friendly to us, but we will still investigate there. But we'll definitely start in Michigan, the Upper Peninsula, because we love the Upper Peninsula."

Gonclaves did not reveal where the mineable rare earth minerals were found in the U.P. Cleveland Cliffs owns Michigan's only remaining iron ore mine, the Tilden Mine, located south of Ishpeming. Next door, the Empire Mine has been idled since 2016.

The Tilden has the capacity to produce 8 million tons of iron ore pellets annually, making it one of the largest producers in the world.

Rare earths are a group of not uncommon, but usually highly dispersed metals in the Earth's crust, which are vital to products such as electric vehicle motors, consumer electronics, renewable energy and military systems. They have been in the news recently because they're extracted and refined in the greatest quantities in China and potential trade wars and having their imports cut off could be a security threat to the U.S. supply chain.

"America's industrial foundation must never depend on China or any other foreign source for essential minerals, and Cliffs intends to be part of the solution," Gonclaves said.

Mineral extraction at the U.P.'s Eagle Mine started in 2014. Work leading up to that cost \$469 million and put to work some 500 unionized construction workers. The mine, which continues to operate, has brought about the creation of 480 operational jobs.

A representative for Lundin, which owns the Eagle Mine, last summer said the goal is to keep the mine open until 2027 to 2029. Additional areas at Eagle Mine are continuing to be explore for minerals.

Companies are continuing to look at other U.P. sites for mining opportunities, especially nickel. Old mine waste is also being examined for potentially valuable metals.

Uranium fuel delivery marks milestone for Palisades return

COVERT TWP. - The progression toward splitting atoms again at the Palisades Nuclear Power Plant took a leap forward on Oct. 20, with the arrival of the site's first fuel shipment.

"The Palisades Nuclear Power Plant... has received new nuclear fuel - 68 assemblies in total – achieving a major milestone on the path to restarting the plant," said a statement released by owner Holtec International. "Procuring new fuel was among the earliest long-lead activities in the project, requiring months of technical preparation and regulatory coordination.

"Palisades' historic transition from decommissioning to operations status that occurred with the U.S. Nuclear Regulatory Commission's authorization in late August 2025 enabled the plant to receive new fuel at the site."

The uranium fuel, Holtec d, was fabricated domesti cally "by a highly respected nuclear fuel manufacturer" that has supplied Palisades and others in the nuclear industry for decades. Upon arrival and in-depth quality inspection, Holtec said the accepted batch of fuel was placed in secure storage within the site's "Spent Fuel Pool Building" where it will remain until its loading in the reactor core.

a major milestone for the plant, will be the first U.S. nuclear but is a relatively small portion of the buzz of construction activity ongoing at the nuclear plant.

Located on the Lake Michigan about five miles south of South Haven, the plant is undergoing an historic resurrection - it

OSHA's key General Duty Clause floated for watered-down role

WASHINGTON, D.C. - The Occupational Safety and Health Administration is one of the few federal government agencies that specifically sets standards for the on-the-job well-being of the na-

Over the years OSHA's budgets have been reduced, its rules have been made less effective, and hiring of inspectors has fluctuated. But until now, one bulwark of OSHA has remained unaltered: the "General Duty Clause," which is a catch-all rule - albeit being difficult to enforce – that requires employers to provide a workplace "free from recognized hazards that are causing or are likely to cause death or serious physical harm."

Now, that general clause is seeing its first specific threat under a new proposal by the Trump Administration.

Trump's OSHA is scheming to not enforce the General Duty Clause at all in occupations featuring "inherently risky professional activities," as the proposal's title proclaims. The Trump DOL's proposal itself

lists a total of 115,400 workers it would leave bare of protection: professional athletes, animal trainers, actors, dancers, musicians, singers and "all other entertainers and performers, sports and related workers."

The fear is that this is a trial balloon to apply the exemption to even more worker classifications. The proposal was published before much of the federal government, including virtually all of OSHA, shut down.

"In a nutshell, if the rule were issued, employers would have no general legal obligation to furnish workers in such occupations with a workplace that is 'free from recognized hazards that are causing or are likely to (Continued on Page 3)

Labor can't grow without taking on bigger targets

Last year, U.S. unions cautiously celebrated a turnaround in their organizing fortunes. but taking on National Labor Relations Board election win rates had reached 79 percent, and the number of workers organized for the year approached 100,000, the highest number since 2009.

Yet these gains masked a harsher reality for labor, even before the disastrous 2024 elections. For the labor movement to grow, it needs to organize millions of workers each year, not 100,000. Organizing continues to lag in fast-growing, low-density sectors such as personal services,

IT, finance, and health care, while union-heavy sectors like government and manufacturing keep shedding jobs.

Many organizing victories of the last few years - including landmark wins at Amazon, Starbucks, REI and Trader Joe's - have yet to yield first contracts, as employers refuse to bargain and some go so far as to challenge the legitimacy of the

And things have only gotten harder since Trump began his second term, dismantling the regulatory state, detaining and deporting immigrant workers, and stripping a million federal workers of collective bargaining rights.

Avoiding hard targets. Starting around the time of the first Trump Administration, many unions responded to the increasingly challenging organizing environment by shifting to campaigns for smaller bargaining units in firms and industries less central to the global economy, where unions had more leverage to restrain the employer's antiunion campaign.

New effort seeks to re-reform state's Workers' **Comp law**

LANSING - Michigan workers injured on the job have been receiving reduced benefits from the state's Workers' Compensation system since 2011 and they have had to jump through more hoops to get money

that is available.

But the state House Labor Caucus is now making an effort to reform the state's Workers Comp system and restore some of those lost benefits and take away some hurdles for injured workers. Caucus members, all Democrats, held a press conference on Oct. 30 to in-

troduce a bill package, House Bills 5177-5191, aimed at rebalancing workers' compensation standards.

"For far too long, the workers' compensation system has failed the very people it was designed to protect," said state Rep. Brenda Carter (D-Pontiac), (Continued on Page 2)

World War I 'Tin Derbies' used to shed raining rivets

When helmets became hard hats

From The Electrical Worker, a publication of the IBEW "Helmets to Hardhats" is the name of an organization that helps

transition military veterans into building trades union jobs. The origin of the term, however, dates back much further.

In 1931, it was IBEW members who first converted their helmets to hardhats and introduced a fundamental piece of safety equipment now used around the world.

In October 1931, a 25-story post office building was under construction in Boston. As the ironworkers traversed wooden planks on the upper floors, members of IBEW Local 103 began electrical work on the lower floors. In those days, it was customary for the stray bolt, nut or rivet to fall through the planks, but on this particular job the incoming barrage had become an epidemic.

In an article from the December 1931 Electrical Worker, Local 103 members detailed the dangerous working conditions. "Red-hot rivets have been plunging down through the web," Local 103 Business

Open or shut, NLRB at risk The government shutdown ended this week with nearly a quar-

ter of the federal workforce ending its furlough. That means that more than 600,000 workers have not been performing important federal service jobs – and were not receiving a paycheck.

Still, while some federal agencies were working in limited capacity, many worker protection agencies have ceased the enforcement of our nation's labor laws.

For example, the National Labor Relations Board (NLRB) had ceased almost all case handling, including conducting routine union elections and investigating unfair labor practice charges. This means workers' ability to exercise their right to form unions or hold their employers accountable for violating the National Labor Relations Act (NLRA) were on hold until the government reopens. However, even as the government reopens, workers' rights will still be under attack due to pre-shutdown actions of the Trump administration.

The NLRB is the sole agency responsible for interpreting and enforcing the NLRA for more than 100 million private-sector workers. However, Trump has attacked the agency's independence, illegally firing Board Member Gwynne Wilcox because he did not like her decisions "disfavoring the interests of employers."

Further, Trump issued Executive Order 14215 giving himself and the attorney general the authority to issue interpretations of the law that place independent agencies like the NLRB under their control. Congress designed the board to function as an independent quasi-judicial agency, with board members deciding cases based on the law and evidence. The NLRB's independence is essential and supported by its legislative history and decades of jurisprudence.

Currently, the Board has only one remaining member. Trump nominated Scott Mayer, the chief labor counsel at Boeing, and James Murphy, a longtime NLRB lawyer, to be members of the Board. At a recent hearing on their nominations, they stated that, as Board members, they would "follow the law" but failed to acknowledge that Trump's executive order essentially equates Trump's position to "the law."

As the government shutdown concludes and regional offices resume case handling, the absence of a quorum and concerns around the agency's lack of independence will create obstacles for workers who are trying to exercise their rights under the NLRA. By firing Wilcox for "disfavoring the interests of employers," Trump has created the expectation that future Board members are expected to side with employers over workers, effectively destroying the agency's independence and robbing private-sector workers of the only forum available to them to protect their organizing and collective bargaining rights.

Despite claiming to be pro-worker, President Trump has consistently put forward policies that benefit employers over workers. If the Trump administration really cared about workers, they would sufficiently fund worker protection agencies. Instead, they have proposed decreasing the budgets of these agencies. If the Trump administration really cared about workers, they would propose regulations that strengthen and expand worker protections. Instead, they have put forward a deregulatory agenda that make workers less safe and more vulnerable to wage theft.

If the Trump administration really cared about workers, they would pass labor law reform that would ensure all workers would have the right to organize and bargain collectively. Instead, President Trump has stripped federal workers of their collective bargaining rights and Congress has failed to pass meaningful labor law reform. It is now up to Congress to defend the independence of the NLRB and to protect workers' rights.



Wooden steering wheels for cars? Wooden bicycle wheels? They sound like quaint relics of an earlier era of American manufacturing – and they are.

But with the science of metallurgy and the invention of plastic decades away from offering better alternatives, making those products out of wood once proved to be a popular option for bike and auto manufacturers.

Surrounded by hardwood forests, tiny Onaway in Presque Isle County became an unlikely, outsized, and for a time, an indispensible center for the production of wooden steering wheels and bike rims. Until it all ended, abruptly and tragically, at the town's American Wood Rim Co. plant on Jan. 14, 1926. That morning the spread of a spark in the site's sanding machine turned into a devastating fire that completely changed Onaway.

On one hand, of course, we will never know what might have happened to Onaway if the fire never happened. On the other hand, we know that wooden automobile steering wheels would have a limited life, but the company lived on, manufacturing other wooden products into the 21st Century after it relocated downstate to Alma.

The American Wood Rim Co. had intense competition from other U.S. wood products companies – but it still had an outsized influence as a supplier to the automotive and bicycle industries. In fact an April 1908 publication of the U.S. Department of Commerce and Labor said the American Wood Rim Co. is "a corporation which has a practical monopoly of the output of wood rims in the United States."

Even so, Onaway never recovered when the company decided not to rebuild there after the fire, and moved its operations 160 miles south to

"E.J. Lobdell was a manufacturer of bicycle parts, including saddles and wheels, operating out of Ohio," said an entry in Atlas Obscura. "In 1901, he moved his business to Michigan to take advantage of the state's abundant hardwood supply. Over time, and with the advent of the automobile boom, Lobdell shifted his manufacturing business away from bicycle parts. He started making steering wheels for the cars being built in Detroit, and called his new venture the American Wood Rim Co. It went on to become the world's largest supplier of wooden steering wheels for automobiles, as well as boats, tractors, and other vehicles."

According to the Onaway Historical Museum, "the Lobdell Emery Manufacturing co. was involved in lumbering, sawmill operations and the making of such products as dowels, broom handles, and coat hanger stock." The museum said the sister company Lobdell founded in 1901, the American Wood Rim Co., "was the world's largest and finest producer of automobile steering wheels and bicycle rims."

Lobdell purchased forested land in Onaway from Cheboygan timberman Merritt Chandler, who owned 40,000 acres and would only sell to lumber companies willing to move to Onaway and employ local set-

and woodwork manufacturing plant in Onaway in 1901," said a history prepared by the Onaway Outlook. "There was an annual cut of 20 million feet of hard rock maple per annum, so as to manufacture from this timber straight-grain hard rock maple rim strips suitable for the rim work."

With the presence of the American Wood Rim Co. and its sister company, the Lobdell Emery Manufacturing Co., Onaway experienced tremendous growth in its early years. The big industry, along with the profitable timber business made Onaway the biggest little town in northern Michigan, said the Onaway Historical Museum.

"According to one report, Onaway had two newspapers, three lawyers, four doctors, three large hotels, 17 saloons, nine churches, two bakeries, a fairgrounds, racetrack and an opera house in the pre-fire days," the museum account says. "The figure varies, but Onaway's population was approximately 4,000 and the two huge industries employed anywhere from 1,200 to 1,500 persons,"

While Henry Ford was manufacturing wooden Model T parts, including steering wheels, from forest land he owned in the Upper Peninsula, Lobdell was making and selling wooden steering wheels and other automotive parts to a number of car manufacturers there were hundreds of them at the time.


He sold steering wheels to Duesenberg, Packard, Cadillac, Elmore, Hudson, Oakland, Oldsmobile and Durant Motors companies, among numerous other firms. "Although it's impossible to list all of its customers," the Onaway Historical Museum said, "the American Wood Rim Co., which specialized in making wheels for medium- and higher-priced vehicles, supplied practically all the wheels for trucks and some tractors."

A local Onawayan, Marshall Whitshire, coined the phrase, "Onaway Steers the World," and he received \$5 from the local chamber of commerce for his suggestion.

The 1920s were a booming period for the company. Then came the fire.

At 8:30 a.m. on Jan. 14, 1926, a spark was apparently drawn from a shaft into the

The auto industry soon learned how critical Onaway steering wheels would be to the industry's supply chain. Ray Young, a summer Onaway resident, recalled to the museum that he worked at the Hudson Motor Car Co. in Detroit at the time of the big Onaway fire.

"There I learned first-hand just what a crippling, crushing blow this fire caused the automobile industry," he wrote. "After their 10-day stock of steering wheels was exhausted they had to drive the otherwise finished cars and trucks off the assembly line with monkey wrenches" to control steering.

Lobdell said it would take too long to rebuilt the burnedout Onaway plant. He opted to relocate the American Wood Rim Co. A Jan. 20, 1926 report in the Saginaw News said no less than 60 cities were making a pitch to land the relocated company. "The plant, the largest of its kind in the world, would locate in Alma," the article said. The company would take over the vacant Republic Motor

Truck Co. Plant No. 3. Lobdell told the paper Alma was "admirably adapted" to the needs of the relocated company and to the 700-800 workers he offered to relocate. It had "good water, good schools, ample fire protection good schools and housing conditions." Just like that, Onaway lost half of its population, businesses closed their doors, schools emptied out, and the local major tax base dried up.

American Wood Rim Co. merged into Lobdell-Emery Manufacturing and continued as one of the largest employers in Alma, with a workforce of around 600 people making wood products. They stayed in in business until 2005.

General Duty Clause could see lesser role

(Continued from Page 1) cause serious physical harm," writes Lauren McFerran for the Regulatory Review, a University of Pennsylvania Carey Law School publication. "The proposal depicts this new safety exemption as narrow in focus, targeting only the entertainment and sports industries, but the draft opens the door for a broader reading. Moreover, the implications of carving even narrow classifications of workers and occupations out of the general duty clause could be far more significant than the Labor Department's 'nothing to see here' approach would

suggest." Proposing to exclude professions like athletes and dancers from the OSHA General Duty Clause seems unfair - while they might be in "inherently risky' occupations, don't employers still have an obligation to provide safe turf on a football field to help prevent catastrophic injuries to players? And for dancers, don't employers have an obligation to provide, say, a safe stage?

And there's a reason for the administration's weirdly specific inclusion of "animal trainers." In 2010 an orca trainer at Sea World in Florida died after an orca attack. McFerran said OSHA issued a citation to Sea World under the OSHA General Duty Clause. SeaWorld challenged the citation, arguing that a risk cannot constitute a "recognized hazard" for purposes of the general duty clause when the work involved is "inherently dangerous."

OSHA's citation against Sea World was upheld in the U.S. Court of Appeals, with a majority of the panel holding that the worker/ victim's "assumption of risk" was contrary to Congress's clear direction in the Occupational Safety and Health Act.

The BlueGreen Alliance, a coalition of unions and environmental groups, on Oct. 21 wrote a formal letter of protest to OSHA regarding the attack on the General Duty Clause. The alliance stressed that "for many workers, the general duty clause is the only legal protection."

"In the absence of a specific OSHA rule," the alliance said in the letter, "which takes on average seven years from introduction to implementation, the general duty clause has historically functioned as a safety net for protecting workers when no specific OSHA standard exists for a particular hazard. While this proposed rule has put forth a nonexhaustive list of industries that would be affected by this rule, there is no guarantee that this rule will not lead to additional industries being excluded from the general duty clause and even more workers losing the legal protections it offers."

McFerran concurred: "Indeed, the Sea World (appeals court case) majority made just this point, noting that 'many traditional industries can be extremely dangerous to their employees: construction, metal pouring, logging, welding, firefighting, roofing, electrical power line installation, handling explosives.' These jobs all involve some level of risk, but most reasonable minds would agree that such risks speak to the need for more - not fewer - workplace safety protections."

The broader threat to the General Duty Clause is real, as the Trump Administration is not only aggressively reducing the federal workforce, he has unleashed a pro-business deregulatory agenda that requires agencies to identify 10 regulations to repeal in order to enact one new regulation.



World War I 'Tin Derbies' used to shed raining rivets

Manager George Capelle said in the article. "John Shannon received a fracture of the skull Tuesday while working on the third floor. Gus Chipman was treated for a head injury yesterday. And this morning Augustus Chapman was injured. All are now at Haymarket Relief Hospital."

The electrical workers weren't the only ones in harm's way. Injuries were reported by the Teamsters and the Carpenters. The Ironworkers themselves "had a dispute with the contractor a few weeks ago after several men had been injured, and planking was put up, averting a strike at that time."

Severin Co., the construction firm overseeing the project, released a statement saying "every legal and extra-legal precaution had been taken to prevent rivets from falling" and that "the present planking complies with the regulations and has no cracks for rivets to fall through." But they did fall and the injuries kept piling up, so Capelle took action.

"Putting gray matter into operation, our energetic busi-

ness agent visited a government storehouse and returned with a purchase of discarded army helmets," Local 103 member Harrie Goodwin said. "He ordered his gang of electricians to go into action with precaution. It seemed humorous at first, but it is one of the cleverest safety measures that has been put into practice in this locality for some time."

The sight of "Carnegie stetsons" or "tin derbies," as the helmets were sometimes called, did cause quite a stir. The post office job was soon swarmed by photographers and reporters from Boston's papers, resulting in front-page news.

"The doughboy who tucked away his iron derby when he got back from overseas has found a practical use for it," reported *The* Boston Globe. "By order of Local No. 103, electricians at work on the post office will appear with iron hats as part of their equipment. If a member has no iron hat of his own, snared from the attic, dusted off and polished, he will be rationed a hat from the supply on hand at the government

Soon, the other crafts on the building followed Local 103's lead, and the push for hardhats to become mandatory spread throughout the industry. "The contractor is not legally bound to obey the Massachusetts safety requirements," Capelle said, "but he is morally bound to do so. If the 'tin derbies' fail to protect my men, we might find it necessary to call them off the job."

In the end, the helmets worked and IBEW members were protected. The moral obligation to ensure worker protection, a founding principle of the IBEW, was once again the driving force that led to an industry standard.

Though unorthodox, it was the ingenuity of IBEW members that saw a solution where no one else thought to look. As Goodwin said: "Little did the boys think when bullets were plinking against the tin helmets in the trenches, that the day would come when they would be worn as backstops for rivets. But sometimes, that is how it comes

ness, professional, and personal services. Although employers in these firms may oppose unions no less fervently than their counterparts in manufacturing or high tech, they are less mobile, and their client and donor relations put more constraints on their ability to engage in blatant unionbusting.

Meanwhile, over the past two decades, elections in labor's traditional sectors, such as manufacturing, construction, transportation, and utilities, have dropped at a steeper rate than the decline in employment in these sectors.

The biggest private sector union wins in recent years have been in graduate student units in private universities such as Columbia, MIT and Cornell. Unions such as IFPTE and OPEIU have set up new nonprofit divisions, focused on organizing advocacy organizations and grant-funded institutions such as museums. Small independent unions, such as the Campaign Workers Guild and United Campaign Workers, have targeted political campaign staff.

Unions have also been running fewer campaigns outside the NLRB process – that is, they're making less frequent use of tactics like pressing the employer to voluntarily recognize the union if a majority of workers sign petitions or cards, demanding at the bargaining table to expand the union to cover unorganized units of the same employer, or pushing for elections supervised by community organizations rather than the NLRB. Where unions have used these tactics, it has again been mostly in smaller units in the nonprofit, media and service

sectors. Comprehensive campaigns. Each decade from the 1980s to the early 2000s, more employers ran more aggressive campaigns. But according to soon-to-be-published research I conducted with a team of student researchers, during Trump's first administration, employer campaigns became less intensive, on average, than they had in the past. Union win rates actually increased.

That wasn't because Trump

ment-side lawyers every Republican president appoints. It was because unions chose easier targets.

Between 2016 and 2021, employers failed to mount any campaign against the union in 13 percent of NLRB election campaigns – not one letter, leaflet or captive-audience meeting. Yet, if the elections were weighted to reflect the same types of firms unions were organizing 20 years earlier, unions would actually have faced significantly more intense employer opposition and would have won fewer elections.

Most employers continue to fight unions tooth and nail. Unions are increasingly avoiding these fights.

Because union and employer campaigns respond to each other, union campaigns also declined in intensity between 2016 and 2021. Fewer than a quarter had organizing committees representative of the workplace, ran campaigns that engaged community allies, involved other unions or the media, or held rallies and job actions. Even fewer (just 5 percent) mounted global solidarity campaigns or engaged with unions at other branches of the parent company.

Most importantly, even in campaigns where they faced more aggressive employer opposition, most unions continued to pick and choose a few tactics rather than develop a more comprehensive organizing strategy.

Comprehensive campaigns systematically deploy a broad range of tactics including strategic research, representative rankand-file organizing committees, volunteer organizers drawn from the membership, a focus on issues that resonate with workers and the community, escalating actions in the workplace and beyond, the development of leverage via alliances with sympathetic politicians, community organizations, and other unions (in the U.S. and abroad), and preparation for the first contract fight during the organizing campaign.

They also provide sufficient staff and financial resources to carry them out.

was pro-union - he stacked the that comprehensive union orgaretail and wholesale, and busi- NLRB with the typical manage- nizing campaigns are associated with significantly higher union win rates, even when controlling for employer opposition and the organizing environment – and this continues to be the case today.

Can't afford to wait. It should not be surprising that unions are shifting their focus toward the kinds of companies they believe will yield the most success in organizing. Workers in smaller units in the service, retail, and nonprofit sectors need and benefit from unions no less than their counterparts in larger firms in more mobile sectors of the economy.

However, there are costs to this trend. Unions are winning fewer workers, in smaller units, and increasingly those wins are at the margins of the economy. As we have witnessed in the first year of the Trump Administration, the world's largest and wealthiest corporations are increasingly driving our nation's economic and social policies.

Difficult as it may be, unions must organize workers in the nation's largest and most powerful corporations, and they cannot afford to wait for labor law reform or a more favorable administration to do so.

To build worker power during the second Trump Administration, unions will need to learn or relearn how to organize outside the NLRB process and without the benefit of federal government enforcement. And they will need to do it with the same scale and intensity that they used to win major strike victories at the Big Three automakers, hotel chains and Hollywood in 2023.

Most importantly, unions will need to leverage the power of workers and their allies, through worker- and community-centered, strategic, multifaceted, and escalating campaigns, to make the cost of fighting the union greater to employers than the cost of recognition and bargaining a fair agreement.

It won't be easy – but taking on corporate power never is.

Plumbing Law Changes: Starting March 20, 2025, anyone performing plumbing work in Michigan must either be registered and in good standing with the State as a plumbing apprentice or hold a current journeyman or master plumbing license. The new legislation also establishes a ratio of one journeyman for every two apprentices, with significant penalties, including steep fines and the suspension or revocation of a plumbing contractor's license for non-compliance.

This is excellent news for our industry and presents a great opportunity to expand our market share in West Michigan. Make sure that your license or apprentice registration is up to date with the State. If your license has expired or you need to register as an apprentice, you must contact the State Licensing Division at 517-241-9316.

Contract Ratification: At the special called meeting on July 1st, the members voted to accept the bargaining committee's recommendation and ratify the new three-year collective bargaining agreement. The new agreement is as follows:

1st year \$4.20/ 2nd year \$3.30. 3rd year \$3.30/ \$10.80 over 3 years.

Language changes: Section 13.2 - reduces the number from issuing orders from 4 to 2 to

receive foremen pay. Section 10.2 - Health care will be on hours paid not hours

*The contractors will now be administering the ESTA benefit.

Organizing Update: We are on a recognition strike with Moore Mechanical. What does this mean? Moore Mechanical is failing to recognize LU 174 as the bargaining representative for the majority of the plumbers that want union representation. 



Uranium fuel delivery marks milestone for Palisades return

the nuclear power community
across the world.

"The esprit de corps of our tirelessly toiling worker force, over 1,800 strong boosted by the stout support of federal, state, and local government as well as our industry partners, labor, and the Southwest Michigan community, is a testament to the national consensus and our collective will to harness nuclear energy to meet the galloping demand for power in our country," says Holtec's CEO, Dr. Kris Singh.

The Palisades plant's 777-megawatt pressurized water reactor began operation in 1971. It operated for more than half a century before being shutdown in May 2022 by then-owner Entergy, who said its operation was no longer commercially viable.

With the Biden Administration's push for more green energy sources – aided by a \$1.5 billion federal loan plus state money – the shutdown didn't last long. Holtec purchased the plant to decommission it, but instead in late 2023 opted to go through the laborious process of renovating and upgrading its works in the effort to place more than 800 megawatts of baseload power back on the grid.

Holtec said last month that ongoing work includes progress on major equipment restoration work across the plant. Reassembly of the main turbine generator is underway following more than a year of inspection, testing, and maintenance work. The plant also has recently received and installed the second (and last) fully refurbished primary coolant pump (PCP) motor, which is essential to recirculate the reactor coolant.

Another significant piece of restorative work is the chemical cleaning of the secondary side of the steam generators. This work effort follows successful completion of refurbishing of the steam generators' tubes earlier last summer and is intended to ensure long-term reliability and efficiency of the plant.

"The above-mentioned major milestone achievements headline hundreds of activities that our dedicated personnel are tackling to deliver the project," Holtec said last month.

Another historic "first" at the plant: the building trades will be installing a pair of "small modular reactors" (SMRs) at the site, which will add a total of 600 megawatts of power capacity.

They are expected to come online in 2030, and will be the first of their type installed in

the nation

SMRs, according to the International Atomic Energy Agency, are advanced nuclear reactors limited to 300 megawatts per unit that are physically a fraction of the size of a traditional nuclear reactor. They're factory-assembled and modular for transport to a location for installation. So far, Holtec said to avoid disruption of ongoing restart work, on-site SMR activity has been limited to site preparation and geotechnical work on the land where the twin 300-megawatt units will be built. When the plant will again start producing power is unknown -Holtec, the U.S. Nuclear Regulatory Commission and the various industry publications following the project have been silent this year on providing a date. The NRC in September issued its final environmental assessment for the plant's reopening and found "no significant impact," part of a series of the agency's approvals of licensing and regulatory actions to transition the Palisades Nuclear Plant from decommissioning status back to operations.

The notorious, former Three Mile Island nuclear power plant in Pennsylvania, which experienced a partial meltdown in 1979, will follow in the Michigan plant's footsteps. Constellation Energy is currently working reopen that nuclear facility – renamed Crane Clean Energy Center – by 2027.

Once operational, the Palisades site will support "600 highly-skilled, permanent local jobs," Holtec said, along with more than 1,000 contract workers during regularly scheduled refueling and maintenance outages.







Restoring native rice to Michigan

Building on a longstanding partnership with Indigenous nations, the Michigan Department of Natural Resources is intensifying its commitment to sowing manoomin, a native aquatic rice and staple of the Anishinaabe people.

The DNR's Wildlife Division, working with the Keweenaw Bay Indian Community, has seeded thousands of pounds of manoomin in the western Upper Peninsula over the past decade and, more recently, expanded these efforts to the eastern U.P.

This year, the DNR finalized a manoomin-seeding agreement with the Brimley-based Bay Mills Indian Community and continues working toward a similar agreement with the Sault Ste. Marie Tribe of Chippewa Indians.

In addition, the Wildlife Division hosted its first-ever manoomin camp in mid-August to educate employees from the DNR and other state departments on the cultural, spiritual, ecological and economic significance of manoomin to indigenous communities. Tribal nations have been working for decades to restore manoomin, which became Michigan's official native grain in 2023.

Fifty-eight people attended the DNR's two-day manoomin camp at the Ralph A. MacMullan Conference Center in Roscommon, where tribal instructors led sessions focused on ceremony and traditional teachings that included harvesting tools, seed care and processing. The instructors represented the BMIC, KBIC, Saginaw Chippewa Indian Tribe, Little River Band of Ottawa Indians, Cree Nation and Gun Lake

"The goal of the camp was to raise awareness of the ecological importance of manoomin on the landscape as well as the cultural and spiritual significance of wild rice," said camp organizer Bill Scullon, a U.P.-based field operations manager for the DNR

"We want to work with our tribal partners whenever we can," Scullon added. "It's important to create these types of collaborative opportunities – to tear down barriers and open doors."

'The good berry.' Native to the Great Lakes region and parts of Canada, manoomin – which translates to "the good berry" in Ojibwe – is a grain-producing grass. It grows to 6-10 feet tall in the shallow, quiet waters of marshes, inland lakes and slowly moving streams.

Manoomin is a culturally significant plant to the Anishinaabe (Odawa, Ojibwe, and Potawatomi) and is directly linked to their migration from the northeastern U.S. coast to the Great Lakes region several hundred years ago, according to *Native News Online*, an American Indian news publication. In the Great Lakes region, manoomin plays a major role in the indigenous food sovereignty movement.

rice," said camp organizer Bill
Scullon, a U.P.-based field operations manager for the DNR
Kathleen Smith is with the
Great Lakes Indian Fish & Wildlife Commission, where she

serves as Genawendang Manoomin – or "She who takes care of the wild rice" – for tribes across Michigan, Wisconsin and Minnesota. Smith, a member of the KBIC, gave several presentations at the DNR wild rice camp on manoomin harvesting, storage and cultural awareness and respect.

"With the continued decline of wild rice across many of our lakes and rivers, I often reflect on the teaching, 'If we don't use it, we lose it,'" Smith said. "That truth echoes louder each year. Our wetlands and the manoomin that grows within them are truly important to our people."

Power of partnerships. In 2025, the Wildlife Division sowed about 2,200 pounds of manoomin seed, continuing its annual efforts to help restore or establish wild rice within state-managed rivers, creeks and wetlands in the U.P. Once manoomin matures in early fall, the rice grains provide energy-rich food for migrating

waterfowl and are harvested by Anishinaabe communities.

The DNR obtains wild rice through formal agreements with tribal communities. Through these collaborations, tribal partners request manoomin seed from their network of vendors in Wisconsin and Minnesota, ensuring the wild rice is sourced responsibly, aligning with cultural teachings and ethics.

Scullon and John DePue, a U.P.-based wildlife biologist for the DNR, were instrumental in the department's initial efforts to partner with KBIC to help restore manoomin.

"We recognized early in the partnership that KBIC has the cultural expertise, historic knowledge and resources to be a guiding partner in this process," Scullon said. "KBIC, working in conjunction with the Great Lakes Indian Fish & Wildlife Commission, has the technical knowledge on where, when and how to restore manoomin. They have helped us to select, evaluate, seed and monitor sites for rice restoration."

DNR wildlife biologists Kristie Sitar, Brian Roell and David Jentoft have played key roles in expanding the partnerships with other tribal nations in the eastern U.P. Sitar helped develop a memorandum of agreement between the DNR and the Bay Mills Indian Community.

"These partnerships are critical in maintaining the quality of rice used and are helpful to us working together to select the most appropriate places and desired efforts," Sitar said.

Sitar and Roell received a

U.S. Environmental Protection Agency grant in 2021 to reestablish wild rice in northern floodings along Lake Superior. The goal was to seed manoomin for three consecutive years at four locations – three in Marquette County and one in Luce County – at a rate of at least 50 pounds per acre in suitable flooding habitats. From 2022 to 2024, project staff seeded more than 2,600 pounds of rice in northern Luce County and more than 2,800 pounds in three northern floodings in Marquette County

"We started to see success as rice seed germinated and grew and then began to self-seed in successive years," Sitar said. "We had to adapt by dealing with some wildlife browse issues that commonly occur during this process. Wild rice can take many years to become established, and we are on our way to hopefully long-term success."

Scullon noted that in Michigan, anyone can harvest manoomin, while in Wisconsin the practice is illegal for the general public without a permit. The Michigan Wild Rice Initiative – which consists of tribal nations, the DNR and other agencies and groups – is working to develop a cooperative framework to regulate the responsible and ethical harvest of manoomin in Michigan.


