### U.P. Construction Council job opening

### \$2T plan would be a jobs machine

President Joe Biden has released his plan for a massive infrastructure bill, which is subject to approval by Congress.

The \$2 trillion plan would invest serious capital in revitalizing the U.S. transportation infrastructure, water systems, broadband, and manufacturing.

Some of the specifics in the proposal include:

- \$621 billion to fund transportation infrastructure, including rebuilding roads, bridges, public transit, ports, airports, and electric vehicle development.

- \$580 billion for American manufacturing, research and development, and job training efforts.

- \$400 billion to create a health care infrastructure to care for elderly and disabled Americans, including rebuilding or repairing many VA facilities.

- \$300 billion to improve drinking water infrastructure, expand broadband access, and upgrade the electrical grid.

- \$300 billion to build and retrofit affordable housing, along with constructing and upgrading schools.

In Biden's announcement of the plan, the administration set a goal to revamp 20,000 miles of roads and highways and repair 10,000 bridges. They also want to create a national network of 500,000 electric vehicle chargers by 2030.

To improve the nation's drinking water, Biden has proposed replacing all lead pipes within the nation's water system. They also want to finally deliver universal, affordable broadband to the entire nation.

Additionally, funds will be used to build or retrofit 500,000 homes for low- and middle-income Americans. The administration also said that they wanted funds to ensure that everything from schools and transportation to utility grids is made more resilient in marginalized and lower-income communities where investment hasn't always been as high as in wealthier communities.

The plan would spend about \$16 billion in investments to plug countless defunct oil and gas wells and to reclaim abandoned coal mines. The Biden Administration expects this money will put hundreds of thousands of people to work in union jobs. Many of those people will be workers whose jobs have been lost or are in danger of being lost due to the move to more renewable energy.

These projects will be subject to the federal prevailing wage law and would generate millions of good-paying union jobs.

## Ban union organizers from employer land? Supreme Court takes a look

WASHINGTON (PAI)—Worker opponents, led by two big California growers, the Chamber of Commerce and other right-wing interests, urged the U.S. Supreme Court to literally ban union organizers from ever contacting workers on job sites, even in break rooms and in off-hours.

And in a March 21 oral argument, those same right-wing interests largely downplayed the greater implications of their written briefs sent to the justices beforehand: That private property owners could ban federal and

other government inspectors, too. The case potentially has enormous implications for broadening the rights of business property owners to disallow access to their property.

"Reasonable government inspections are a background principle of property law that do not affect your property right or your right to exclude," the growers' attorney, Jacob Thompson, told Chief Justice John Roberts during the session via Zoom on *Cedar Point Nursery v. Hassid*.

At issue were California Agriculture Labor Relations Board rules, challenged by the growers.

The rules let union organizers contact workers on farms — private property — only if there's no other way for them to do so.

The union contacts are limited in hours and days. But Thompson argued to Justice Barrett any intrusion on private property, even if only for one hour once a year, is a "taking" of the owner's property rights "without just compensation" and unconstitutional.

"In our case, the government is not searching" or inspecting. "It is authorizing third parties" — union reps — "to come on to proselytize," Thompson told Justice Clarence Thomas.

Justices Stephen Breyer and Amy Coney Barrett called them on it. "They send someone out there," Breyer said, referring to government agencies, "as here, to talk to workers to find out what the conditions are, for example. Can they do that?" Thompson's one-word answer: "No."

Justice Breyer responded: "They're searching for conditions. They're searching to see whether they'd like to belong to a union. They can't do that. What's the difference?"

"If it is a power the government possessed at common law,"

## WMU aviation school expands at Battle Creek's Kellogg Airport

BATTLE CREEK — A \$20 million expansion and renovation of Western Michigan University's Aviation Education Center is in its final approach, in a project that will go a long way toward improving the way future pilots and air-industry personnel are educated.

Located at W.K. Kellogg Airport in Battle Creek, the project will add classroom space, a computer room, composites/paint laboratory upgrades, a state-of-the-art simulation center, a research center, student briefing rooms, faculty office space, a café and other amenities, as well as the latest technology, according to WMU. The expansion will expand the former airport terminal

from 16,000 to 67,000 square feet.

"We will increase our classrooms from four to 10, greatly improving the scope of our instruction and research capabilities," said WMU College of Aviation Dean Dave Powell. "The needs of our industry are tremendous, and these trends are expected to

## MI Dems make improbable attempt to reinstate prevailing wage

LANSING — State House Democrats are attempting to resurrect prevailing wage for the state's construction industry.

It's almost certainly a hopeless effort, given that there is no reason to think there is a change of heart by state Republicans,

who continue to control both the state House and Senate, and who pushed through the repeal of the Michigan Prevailing Wage Act in June 2018 without a single vote by a Democrat lawmaker.

House Bill 4594, sponsored by state Rep. Brenda Carter (D-Pontiac) calls for reinstatement of the law, which requires that on

taxpayer-funded projects, construction worker wages "shall be not less than the wage and fringe benefit rates prevailing in the locality in which the work is to be performed." Carter introduced the bill on March 25, and a related online press conference was held March 31.

## 'We congratulate our proud union brother' Senate OKs Laborer Walsh as new Labor Dept. secretary

WASHINGTON, D.C. — By a 68-29 margin, with all the "no" votes coming from Republicans, the Senate on March 21 confirmed Boston Mayor Marty Walsh, a member of the Laborers union, as U.S. Secretary of Labor. He's the first unionist to hold the job in decades.

"Workers who are the backbone of our economy have been pushed to the brink. They need...Marty Walsh so we have a secretary who will take quick action to address the urgent challenges we face and be a valuable partner in helping our economy come back stronger and fairer for all workers," Senate Labor Committee Chair Patty Murray, D-Wash. told her colleagues.

The "road to recovery," Murray said, from the coronavirus pandemic and resulting economic depression "is long, and there are still many steps we need to take, including raising the federal minimum wage to one fair wage of \$15 an hour, passing the Pro Act into law to strengthen workers' right to join a union, and passing the Be Heard in the Workplace Act to

protect people from harassment, assault, and discrimination. We have a lot to do and no time to waste...We need a secretary of labor we can trust to stand up for workers and not huge corporations."

Walsh, who resigned his position as mayor of Boston to take over as the new secretary of labor, is a card-carrying member of the Laborers Local 223. Prior to being mayor, he was president of the Boston Building and Construction Trades Council.

AFL-CIO President Richard Trumka cheered Walsh's success. "For four years, the Department of Labor has been devoted to serving a handful of elite interests, instead of working people. Not any more," Trumka said. "We congratulate our proud union brother. He understands the power of collective action, and his

## Tesla's anti-union 'insignia' rule gets tested at NLRB

Unless there's a "special circumstance" identified by an employer, current U.S. labor law allows workers to wear clothes and uniforms on the job with union insignia (buttons, pins) and printed union logos.

But that concept is now being revisited by the National Labor Relations Board, which is reviewing a 2019 case decided by an administrative law judge involving the anti-union automaker Tesla. The judge issued a decision that Tesla violated labor law by prohibiting production associates from wearing union-logo shirts, a shirt ban that was part of a series of unfair labor practices that Tesla was found guilty of.

Fast forward to February

2021, when the NLRB — a panel still controlled by anti-labor Trump appointees until August — asked the public to submit comments on the case on whether it should change its legal test for union insignia. Pro-business groups like the U.S. Chamber of Commerce and the HR Policy Association filed briefs calling for the pro-union, Obama-era standard to be overturned.

A memo from Biden-appointed Acting NLRB General Counsel Peter Ohr asked the NLRB to retain the current policy on wearing union insignia at work. Ohr's brief, said *Bloomberg Law*, "is another sign of his willingness to carry out a pro-union agenda even as the Biden administration's general counsel nominee Jennifer Abruzzo waits for Senate consideration."

"Ohr, in one of his first acts as the head of the NLRB's legal arm, cited the National Labor Relations Act's stated goal of encouraging collective bargaining and protecting workers' rights. He also said he wouldn't spend his time in office as a 'potted plant.'"

The business group's briefs with the NLRB, Bloomberg said, said the existing standard "puts an excessively high burden on employers to prove their neutral uniform policies comport with federal labor law."

The AFL-CIO and Service Employees also filed briefs, defending the existing standard. In their brief, the AFL-CIO said that Tesla's prohibition of union shirts was illegal and that under the company dress code, workers could substitute all-black clothing as long as it was work-appropriate, mutilation-free, and didn't create a safety risk. The AFL-CIO highlighted the fact that Tesla only had a problem with workers wearing something other than all

## Challenges? U.S. construction industry has 'em Supply chain woes, material prices beleaguer contractors

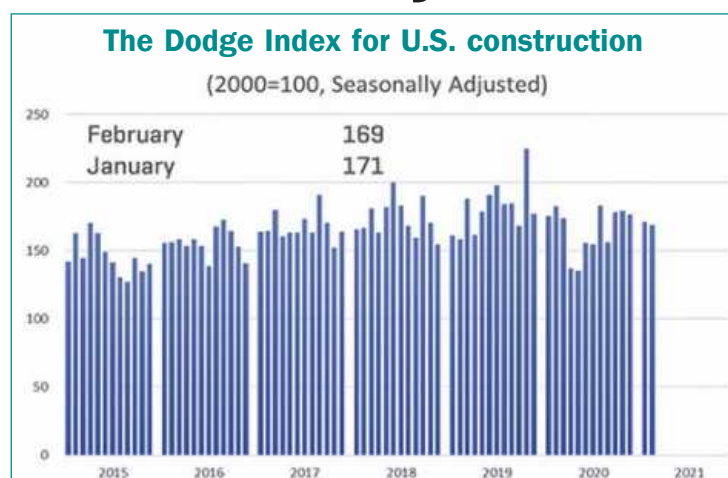
Over the course of the past year since just before the COVID-19 pandemic began, construction employment in Michigan proceeded to whipsaw from seeing many job sites shut down, then roaring back to being among the leading states in creating jobs, to settling down in the middle of the pack.

A year later, the new normal in Michigan and elsewhere shows an industry struggling to regain

its footing. Certainly it's not a gloomy picture everywhere — in fact, Michigan has hosted travelers among various trades over the past several months to complete some high-profile projects.

But overall, only two low-population states, Idaho and Utah, gained a significant percentage of construction jobs during the 12-month period from

### Go with the PRO Act

Workers scored a triumphant victory as the PRO (Protecting the Right to Organize) Act passed the House with bipartisan support on March 9, but there is still a long, uphill battle to fight those who have squandered monstrous resources to keep American workers beat down.

The PRO-Act is the most significant worker empowerment legislation since the Great Depression. It will empower workers to exercise our freedom to organize and bargain, end employers' practice of punishing striking workers by hiring permanent replacements, hold corporations accountable by strengthening the National Labor Relations Board, and repeal "right to work" laws that lead to lower wages, fewer benefits and more dangerous workplaces.

Michigan is the birthplace of the modern American labor movement. Our fathers and grandfathers fought, starved and even died to earn a fair wage and safe working conditions in the mines of the Upper Peninsula and the factories of Detroit. For an all-too-brief time, the tentative peace between large corporations and their workers made Michigan one of the most prosperous and equitable economies in the world.

In 1960, Detroit had the highest per-capita income in the United States. The city is now the poster child for the failure of the American dream. The same can be said for the many Upper Peninsula residents who live below the poverty level, in ghostly, fading towns.

Union workers in the Upper Peninsula fare far better than their non-union counterparts, enjoying decent wages and good benefits. But even they are suffering with sustained corporate and government interference with worker solidarity, collective bargaining and the ability to strike. Public sector workers are under constant threat of losing fairly bargained and promised benefits and pensions as our economy continues to shrink. Our local heroes, our teachers, our police officers and our firefighters are told they must continue to do more with less. This type of neo-liberal ideology costs jobs, and has severe consequences for employees who have an unhealthy work-life balance and no recourse to stop it.

All workers deserve union protection! Data indicates that more than 60 million Americans would choose to join a union if they were able. The PRO-Act will hold employers accountable for union-busting activities.

The PRO Act will make America's economy work for working people. Between 1948 and 1973, when New Deal era laws expanded and enforced collective bargaining, hourly wages rose by more than 90 percent. But over the next 40 years – from 1973 to 2013 – hourly wages rose by just over 9 percent while productivity increased 74 percent. The growing gap between income and productivity is a cold, hard fact that illustrates how many businesses have abandoned any kind of responsibility for the real human beings who produce their goods and services with their intellect, their sweat, their blood, and, especially this past year, their lives.

The people of the Upper Peninsula are known for their fierce independence and exceptional work ethic. Unionism has a long, proud history in the Upper Peninsula and those lucky enough to be members still reap many of the benefits our ancestors fought for. We cannot let their sacrifices be for nothing. We can't continue to back down from the fight against corporate greed. We deserve our dignity, our humanity, and our right to have a real voice in our workplaces.

continue as projected increases in passenger traffic fuel the demand for these highly skilled, highly paid industry jobs."

The addition and renovation project will wrap up later this year. Mall City Mechanical foreman Adam Hatfield of UA Local 333 said the project employed 12 plumbers and pipe fitters at peak employment. "It's a nice facility, and our people did a really nice job here," he said.

Western's aviation college has seen its enrollment grow 35 percent in the past five years to about 1,000 students as high job growth and demand for aircraft pilots, aircraft technicians and management place WMU in the position to be Michigan's major resource to prepare students for these jobs, Powell said.

WMU's College of Aviation is among the oldest such academic units in the nation, beginning in 1939 and evolving over time from a single program to its current status as a full academic college in July 1999. It has been located at the W.K. Kellogg Airport in Battle Creek since 1997 and has been the site of nationally recognized intercollegiate flight teams and state-of-the-art flight and technical training initiatives and important research undertakings.

W.K. Kellogg Airport, located about three miles west of Battle Creek and a few miles north of I-94, is the third busiest airport in the state. It is located on a 1,260-acre site and was the third busiest airport in Michigan in 2019. The airport doesn't offer commercial flights, but is the base of operations for about 55 private individuals, as well as the WMU College of Aviation, the Battle Creek Air National Guard,

Duncan Aviation, WACO Classic Aircraft and Centennial Aircraft Services.

Joe Sobieralski, president and CEO of Battle Creek Unlimited, an economic development agency, said of the improvements at the airport: "It is exciting to know that the next generation of

pilots and aviation technicians will be trained and educated right here in Battle Creek. This is not only great for Western Michigan University, but it is also great for Battle Creek—it doubles-down on one of Battle Creek's most strategic assets on the economic development front."

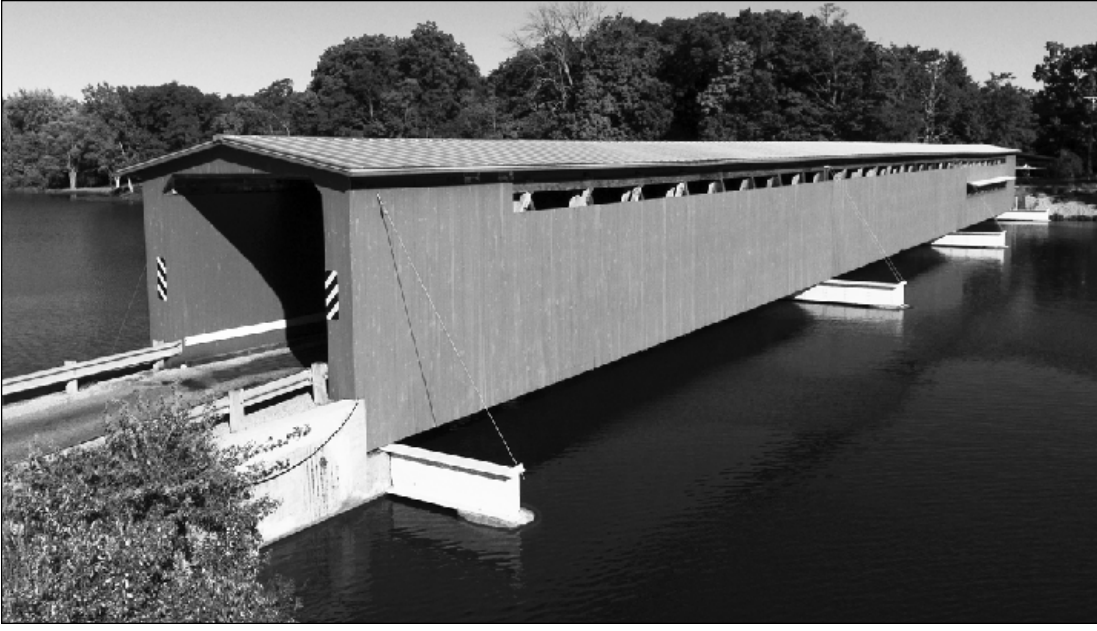

### The Langley Covered Bridge

## HISTORY IN THE MAKING

THE PICTURESQUE Langley Covered Bridge in St. Joseph County, painted a striking shade of red, is one of only a few such bridges remaining in Michigan. The 282-foot-long span, completed in 1887, underwent repairs in 1950-51 after the bridge had been getting stressed with heavier vehicular traffic. The 1951 work involved the placement of four steel I-beams to support the bridge. They rest on concrete piers in the St. Joseph River. In 2008-09 the roof was replaced and siding rehabilitated.

Covered bridges weren't given a roof and walls in order to provide temporary shelter from rain and snow for travelers, although they undoubtedly provided a welcome haven on occasion. Nor were covered bridges built to provide a picturesque photo opportunity – although 19th and 20th Century artists loved to paint them. Today... well of course, nearly everything is a photo op – so new and refurbished covered bridges have often become a destination themselves, while keeping a practical purpose of moving people and vehicles over obstacles.

Actually, bridges were covered for the intensely practical consideration of slowing Mother Nature's inevitable deterioration of the span's deck, foundations and trusses. After all, bridges were expensive public works projects, usually spanning a river, and vital to a community's economic prospects. They were indispensable conduits for the movement of people, vehicles and livestock, and it behooved a community to keep their wooden bridge in good working order by protecting the structure with a roof and walls.

"Covered bridge, timber-truss bridge carrying a roadway over a river or other obstacle, popular in folklore and art but also of major significance in engineering history," says the related entry in the *Encyclopedia Britannica*. "The function of the roof and siding, which in most covered bridges create an almost complete enclosure, is to protect the wooden structural members from the weather."

According to the U.S. Department of Transportation, about 14,000 covered bridges have been built in the U.S., mostly in the years 1825 to 1875, with only a tiny fraction of them still standing. Michigan only has a handful of covered bridges remaining – eight according to a history provided by MLive – with the longest being the Langley Covered Bridge in southwest Michigan's St. Joseph County.

"Stretching 282 feet across the St. Joseph River, the Langley Bridge is the longest of West Michigan's few remaining covered bridges," says Michigan.org. "Langley Bridge is also one of the longest in the nation. Langley Bridge was built in the fall of 1887. The bridge features three spans, each 94 feet long. It is 16 feet high and 19 feet wide."

Located four miles north of Centreville, which is east of Three Rivers and about 13 miles north of the Indiana border, the Langley Bridge is still open to pedestrian and vehicular traffic (one way). It was named for Thomas W. Langley and family, pioneers who helped establish the Village of Centreville in the mid-

1880s. The span has been raised and refurbished over the years, but it has maintained much of its original appearance.

The bridge was designated a Michigan State Historic Site in 1965. Its marker reads: "This is the longest of Michigan's few remaining covered bridges. It is 282 feet long with three, 94-foot spans of the Howe-truss construction. The bridge was built in 1887 by Pierce Bodmer of Parkville, using the best quality white pine for the frame timbers. The bridge's name honors a pioneer Centreville family. When the Sturgis Dam was built in 1910, the Langley Bridge had to be raised eight feet. In 1950-51 extensive repairs and replacement of parts on the bridge were carried out by the St. Joseph County Road Commission to preserve for the future this historic link with a bygone era."

The longest covered bridge in the U.S. is the Cornish-Windsor Covered Bridge (1866) between communities in Vermont and New Hampshire. It has an overall length of 460 feet. The 53-foot long Hyde Hall Covered Bridge (1825) in New York state is the oldest of its type still in existence in the U.S.

The first long covered bridge in America was a 180-span over the Schuylkill River at Philadelphia built in 1806. "Covered timber-truss bridges soon spanned rivers from Maine to Florida and rapidly spread westward," *Encyclopedia Britannica* says.

"The timber truss bridge – especially the covered bridge – is such an American icon that one might think it was invented here," said *Civil Engineering*. "On the contrary, timber trusses originated in Europe. The Romans built them, and in 1570 the Venetian architect Andrea Palladio revived the idea."

The Langley Bridge's employment of the Howe Truss, invented for bridge design in 1840 by American architect William Howe, was a slight, but important advancement on the traditional design of repeating diago-

nal trusses.

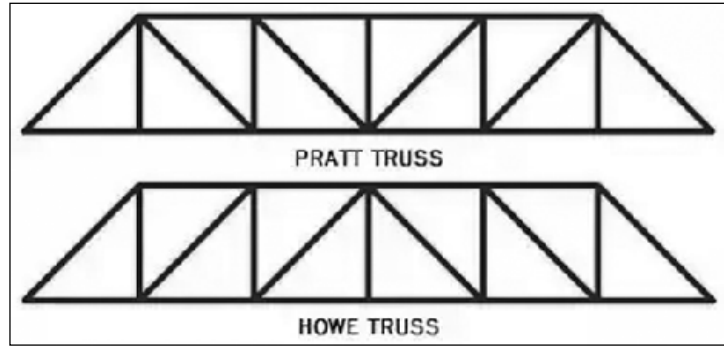
"William Howe did not invent the wooden truss bridge, but he may have perfected it," says a June 2012 *Civil Engineering* magazine article. "The truss he designed quickly became the most popular type of railroad crossing in the mid-19th Century. It also played a key role in the transition from timber to iron bridges."

The Langley Bridge's truss system, obviously visible only from the interior, uses diagonal structural beams in a series of triangles that slope toward the bridge center, while competing Pratt trusses flipped the frame set-up to utilize diagonal beams that slope outward from the center of the bridge. This approach makes diagonal members of Howe truss bridge in compression, while vertical web members are in tension. They were both good designs, but the Howe design was suitable for longer spans than the Pratt truss.

An account of the Langley bridge by *MLive* said "historical accounts say prime white pine logs from Michigan timberlands were floated to the construction site. The bridge's planking rested on 40 beams, each measuring 8 inches by 12 inches and 19 feet long. The side trusses included 180 cast-iron angle blocks that were held in place by 132 heavy rods."

The Langley bridge has a 7-foot height restriction and a three-ton weight limitation. Arches were erected on both sides of the bridge to enforce the height restriction. A new wood plank floor was added in the past few years. The community holds here an annual covered bridge festival to celebrate its landmark.

After extensive work on the bridge was completed in 1951, P.M. Pashby, then-county road commission superintendent, wrote: "We feel its value cannot be estimated. It is one of the intangibles which future generations will thank the (road) commission for as the perfect relic of the old horse-and-buggy days."

# Construction industry has its challenges

February 2020 to February 2021. And only four other states saw positive job growth during those 12 months, all under 2 percent, with 44 states seeing their construction job percentages decline. The numbers come from a March 26 analysis of federal employment numbers by the Associated General Contractors of America.

"Today's figures show most states are still far from recovering the construction jobs lost a year ago," said Ken Simonson, the association's chief economist. "The overall economy is recovering, but huge price spikes and ever-lengthening delivery times threaten to set construction back further."

His comments were echoed by Richard Branch, chief economist for Dodge Data & Analytics: "With spring just around the corner, hope is building for a strong economic recovery fueled by the growing number of vaccinated Americans. But the construction sector will be hard-pressed to take advantage of this resurgence, as rapidly escalating materials prices and a supply overhang across many building sectors weighs on starts through the first half of the year."

Michigan lost 5,700 construction jobs during that 12-month February to February period, a 3.2 percent decline, ranking us No. 23 among the states in terms of jobs gained (or lost). And some of the most populous states

were among the biggest job losers: Texas lost the most construction jobs from February 2020 to February 2021 (-56,400 jobs or -7.2 percent), followed by New York (-41,100 jobs, -10.1 percent) and California (-35,000 jobs, -3.8 percent).

And Michigan certainly has not started 2021 with a bang - the Big Mitten lost 3,200 jobs from January to February, the latest government figures show. The rest of the country also hasn't started 2021 in a strong position: After falling 4 percent from January to February, total U.S. construction starts dropped 2 percent in March, Dodge reported.

The AGC warns that that contractors and owners can expect a wide variety of materials "undergoing steep and frequent price increases and delivery delays," a combination that "threatens to hold up the start or completion of numerous projects and add to the downward pres-

sure on construction employment."

Lumber prices, for one, have gone through the roof during the pandemic. "As of the week of March 11," Fortune reports, "the price of lumber per thousand board feet is at \$1,044, according to Random Lengths. That's an all-time high, and up 188 percent since the onset of the pandemic. The National Association of Home Builders calculates that current lumber prices are adding at least \$24,000 to the price tag of a typical new single-family home."

In addition, the pandemic has led to factory closures, a shortage of truck drivers and a host of other issues that have thrown the supply chain off-kilter. That has led to material shortages and higher costs of items like windows, cement, faucets and appliances, which have led to higher costs and longer lead times for project completion.

## Ban union organizers from employer's land? Supreme Court takes a look

then you do not have the right to exclude the government from undertaking that power," Thompson replied. But union visits are not a government power, he said.

That declaration brought the Chamber of Commerce and radical right groups in on the growers' side and turned the case into a legal "big deal." If they win that big point, firms and farms could bar not just union reps, but government health and safety inspectors and anyone else who might conceivably engage in a "taking" from the business.

The *Wall Street Journal's* analysis of the justices' line of questioning indicated that the business owner's could win at least a partial victory in the case.

"The Supreme Court seemed ready after Monday arguments to pare back union organizers' ability to visit farmworkers in California's agricultural fields," the *Journal* said, "but it was unclear whether the justices viewed the case narrowly or as an opportunity to dramatically expand property rights."

There were indications the court was looking for a middle ground. Conservative Justice Amy Barrett, appointed by President Trump, summed up one potential line of thinking. "Why would it be that big of a deal for California to say to the unions: Listen, to compensate for the taking if you want access, you pay 50 bucks?" she said.

Said liberal Justice Sonia Sotomayor: "I suspect that there's very little economic damage that's being done," by the appearance of union organizers at company property.

The Supreme Court will make a decision by July 1.

black when workers began coming to work with black shirts that had a UAW logo on them. The shirts were specifically designed to comply with Tesla's dress code policy.

"In short, prior to the August 2017 application of the policy to ban wearing black union shirts, there would have been no legal basis for challenging the policy on its face," wrote AFL-CIO General Counsel Craig Becker.

Other unions, said the Union Communications blog, also warned the NLRB that changing the standard could also allow companies to ban other types of insignia that are entwined with the culture of the worksite. The Carpenters union brief said that stickers are often used to indicate specific training a worker has, to promote workplace safety, to identify a jobsite steward, or to remind them of a fallen colleague. All of these could be banned either intentionally or unintentionally if the NLRB rolls back the union insignia rule.

The board's Republican majority – slated to control the five-member panel until at least until one of the three GOP members is replaced in late August – actively chose to solicit briefs challenging the test for union insignia.

"In today's modern world of brand identity and imaging," writes employment attorney Grant Peco for the National Law Review, "the ability to wear union insignia in the workplace is often at the forefront of labor relations. In this regard, the general rule has always been that an employer cannot prohibit union insignia in the workplace absent "special circumstances," even where the employer requires employees to wear uniforms or other designated clothing. However, the application of the general rule to nondiscriminatory uniform policies now appears to be under review."

## Re-institute prevailing wage

"In the long run," Carter said, "studies show that we can save taxpayers money by paying wages to ensure the job is done right. Restoring prevailing wage is a win for Michigan workers, who deserve a fair wage for their skilled labor. It will keep our skilled workforce here in Michigan. It's a win for Michigan's economy, providing funding for apprenticeship programs that will keep skilled labor and money flowing into our local businesses. And it's a win for the Michigan taxpayer, who will receive a better return on their investment in our roads and infrastructure."

Predictably, the Associated Builders and Contractors- Michigan – which funded two costly petition drives leading to repeal of the law and lobbied Republican lawmakers to do the same – panned the legislation. "These bills are a broadside attack on Michigan workers, Michigan taxpayers, and Michigan's middle class," said ABC- Michigan President Jimmy Green, as reported by MIRS News Service.

There has been no reputable research released on whether the State of Michigan saved taxpayers dollars as a result of prevailing wage repeal – although it has been less than three years since repeal and COVID-19 has skewed the numbers over the past year. But research in other states has show that prevailing wage repeal hasn't saved taxpayers any money, while the workers' wages and benefits have been reduced, workers have left the area or the industry because of lower wages and apprenticeship programs have been degraded from lower funding levels.

"Michigan thought that it would save money by gutting the prevailing wage law, and really that turned out to be a short-sighted mistake, a mistake that reminds us of the old saying, you get what you pay for," said state Rep. Terry Sabo (D-Muskegon). "By reinstating prevailing wage we can not only support hard-working Michiganders, and stimulate our economy, we can ensure that we have the most skilled workers, to make sure that public projects are done the first time and built to last."

If your drug test is expired you must take one before you can be dispatched to any GM work. Drug tests are only valid for 1 year. Call The hall and we will print you a drug test authorization form

Sub/Sick checks will be processed 8:00am – 11:30 am and 1:30pm – 4:15pm daily.

**Sub Pay.** Remember to qualify for sub pay when you are laid off, you must sign the out of work list. You can also collect when you are on Jury Duty and miss work. If you are traveling, call Karla to see if you need to make sub-fund self-payments. All members were sent a Sub-Pay manual in 2018. If you did not receive one, please call TIC at (517) 321-7502 and ask for the 370 Sub Pay Fund Summary Plan Description (SPD)

**Attendance award** drawing for membership meeting information. Members present must have dues paid to date to claim award. Monthly award is \$150.

**Attention All Active Members in Good Standing** The Joint Apprentice and Training Committee voted to reimburse any active member of Local 370 who takes and passes any training, testing or certification that may be required to perform their work. This includes Rigging, Med-Gas, Back flow or any work-related training or certification expense. Members will be reimbursed after successful completion and verification of the cost. **Work Report.** The new Meijer in West Branch has been bid. Master Electric has been awarded this project. Master Electric has also secured the new Isabella County Jail located in Mt. Pleasant. Both of these projects will have a spring start. Ted's Electric has been awarded some of the work at Midland Public Schools with Barton Malow being the G.C. Ted's was also awarded the Bay County lift station project. There is also a large energy upgrade project currently being bid for Midland Public Schools. Alpena Schools have been awarded to John's Electric out of Alpena. John's has also been awarded the Alpena library project and a large marijuana grow facility located in Harrisville. Clements Electric has been awarded the Sterling Saw Mill, Monitor Township Fire Department, Bay-Arenac ISD bus garage, the Troll Smokehouse, multiple marijuana dispensaries and the Handy Middle School office renovation.

Another nice project for Bay City Public Schools will be out for bid in the next month. Countyline Power has secured Midland/Gladwin County dam work, the Mackinaw City lift station and the Roscommon Airport. Consumers Energy work for the summer includes Karn 1&2 utility separation, and also work on the generator at Alcona Dam. Northern Valley Electrical has the LaFarge PLC upgrade. Northern Power (Local 498 signatory contractor) has secured work on the Shepler Docks in Mackinaw City. There are also a large number of Solar Projects that are slated for our jurisdiction. We are currently working on a timeline for all solar work. Rest assured both organizers and myself are working very diligently to secure whatever work is being bid in our jurisdiction for our membership. **Organizers Report.** 692's membership development team continues to reach out to those workers in the industry not represented by the IBEW. 

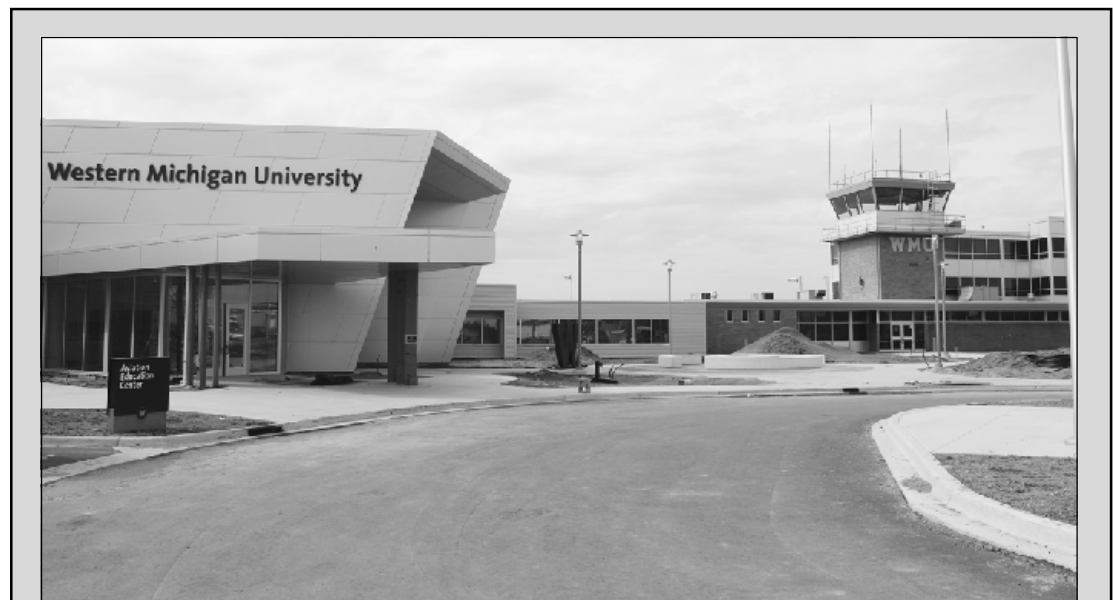

**Labor Department moves quickly to reverse anti-labor edicts**

WASHINGTON, D.C. (PAI)– With one exception, which we'll get to at the end, the federal Labor Department, other agencies and even the GOP-dominated National Labor Relations Board seem to be rushing to reverse Trump-era rules and edicts.

DOL's Occupational Safety and Health Administration will send real inspectors to high-hazard workplaces – especially hospitals, nursing homes, assisted living facilities and meat and poultry processing plants – to ferret out and slam hard on violations of anti-coronavirus protections.

No more phony inspections by phone, as happened under the Trump Administration.

The NLRB dropped the Trumpite General Counsel's challenge to neutrality agreements during union organizing drives, in a case involving Unite Here and a Seattle hotel.

DOL "has suspended enforcement" of Trump rules to curb or even end unions' and shareholder activists' use of proxy votes to force firms to disclose and – in the glare of publicity – change corporate anti-worker, anti-consumer politics and policies.

"Those rules were motivated by corporate lobbying in the previous administration," says Brendon Rees, the AFL-CIO specialist in monitoring corporate and capital markets – a statement that could just as easily apply to all the Trump rules Biden's officials are dumping.

Biden's new Education Secretary, Miguel Cardona, a past member of the School Administrators union, reversed an edict from Trump's Education Secretary Betsy DeVos. She made it virtually impossible for past students of shady for-profit "colleges" to have loans forgiven after their schools went broke. Many students stuck with five- and six-figure bills are women and students of color. DeVos forgave only 3 percent of the loans.

And even Trump's NLRB majority dumped its prior proposed rule, which would have been written in stone like other federal rules, to ban private university research assistants and teaching assistants from unionizing and collective bargaining.

And that's just for starters. The actions, many following President Joe Biden's executive orders, show he was prepared to hit the ground running once he took over the Oval Office.

And though Biden is a congressional veteran, he isn't waiting for lawmakers to move, either. He knows full well that Senate GOP filibusterers would hamstring a lot of his plans.

The DOL led off by dumping two late Trump edicts that sharply curbed workers' rights:

• One Trump scheme would write DOL's "joint employer" rule into the stone of federal regulations. In plain English, Trump wanted to leave workers between a rock and a hard place, unsure of which of their bosses – a local McDonald's or McDonald's corporate headquarters, for example – was responsible for obeying or breaking labor law.

The Obama-era DOL, and its National Labor Relations Board General Counsel ruled both the local boss and HQ are both responsible for following the law, be it bargaining orders (the NLRB) or the minimum wage and overtime pay law (DOL). Before that, suffering workers, who lost wages, benefits and even the right to organize, were being

bounced from pillar to post.

Trump's DOL actually wrote into federal rules, which are tough to repeal, the split responsibility, which leaves workers at sea, unsure who's responsible for not paying them or for breaking labor law.

But last November, a federal judge in New York, responding to lawsuits by workers' rights groups and state attorneys general, called a halt to enforcing that split responsibility workers must face. The judge said the Trumpites broke the law which demands considering public comments on its scheme. Trump's DOL planned to appeal the judge's decision to higher courts. Biden's DOL dropped the appeal, and withdrew the rule.

• The other was Trump's plan, again to be a federal rule, to make more workers "independent contractors," by favoring bosses' declarations that they were.

Unlike "employees" under labor law, "independent contractors" can't organize, and must pay for their and the company's share of Social Security and Medicare payroll taxes. They can't get jobless benefits or workers' comp. They also aren't covered by the minimum wage and overtime pay laws. They're "independent, because they're their own bosses."

Except the workers really aren't. In the real world of construction contractors, port truckers, adjunct professors, franchise restaurants and the gig economy, real bosses control practically everything the worker does, from uniforms she wears to his hours behind the tractor-trailer's wheel. Biden's DOL, specifically its Wage and Hour Division, recognized that.

"The division's mission is to protect and respect the rights of workers. Rescinding these rules would strengthen protections for workers, including the essential front-line workers who have done so much during these challenging times," Principal Deputy Administrator Jessica Looman, its current top official, said in a statement.

"Misclassification of employees as independent contractors denies workers access to critical benefits and protections the law provides. Additionally, removing a standard for joint employment that may be unduly narrow would protect more workers' wages and improve their well-being and economic security."

Biden's Mine Safety and

Health Administration followed OSHA's lead in planning more enforcement in the nation's mines against worker exposure to the coronavirus. The United Mine Workers welcomes that, but wants strong bans on worker exposure to diseases through the air, like the virus, written into law. That's what National Nurses United and other unions demand of OSHA, too.

• Even the NLRB got into the act. New Biden-named Acting General Counsel Peter Sung Ohr – who's holding the spot until the Senate OKs Biden's permanent nominee – trashed a plan by his fired GOP predecessor, Peter Robb, to really curb unions' ability to communicate with workers. The GC is the NLRB's top enforcement officer.

Other media reported "Robb told regional NLRB staffers in September he wanted to tee up" court cases to do more than just ban neutrality agreements, as the venal, vicious National Right to Work Committee sought.

• Robb also solicited right-wingers and corporate interests to bring cases to ban any access to plants by union organizers, even to break rooms and during lunch hours, to let firms refuse to give unions required contact information, and to ban organizers from advocating for a specific union when talking with workers. Ohr banned those bans.

But the GOP majority at the NLRB isn't dead yet, proving it by deciding another case against workers. In plain English, the two Republicans, over objections of sole Democrat Lauren McFadden, said a company could come down hard on workers' "inappropriate communications" on social media postings, whatever that means – and get away with it.

The firm could ban discussing pay and benefits, ban use of company logos to promote the firm (or not) and ban "disparagement" of the firm.

"Legitimate justifications for the respondent's (the employer's) non-disparagement rule are substantial, and we find they outweigh any potential adverse impact of the respondent's facially neutral rule on protected rights" of workers, the NLRB's Republican majority wrote.

Prior to the start of work on the project the employee must provide confirmation of negative results to a MUST Substance Abuse Test or equivalent test within the last 30 days.

**BENEFICIARY REMINDER:** Please remember to designate or update your beneficiary choice on all of your Local 80 and international benefits. The law requires that in the event of an untimely death your benefits go to your spouse first and if there is no spouse to your children UNLESS you designate otherwise in writing with each specific benefit. Depending on your classification you could have benefits due to your heirs from Local 80 pension, insurance, annuity and from international and SASMI. Each individual benefit needs to have a designated beneficiary unless you want it to go to your spouse or children. As always seek the advice of an attorney.

**ADDRESS CHANGES:** If you have a new address please make sure to let the hall know. We will take care of your account with the union hall which includes the Tradesman paper. You will need to call Benesys at 800-400-7710 and update your address with them as well, that is not done through the hall.

**ACCIDENTAL DEATH and DISMEMBERMENT INSURANCE FROM OUR INTERNATIONAL ASSOCIATION:** Members who have their dues paid in advance (prior to the month of the accident) are eligible for accidental death and dismemberment benefits up to \$7,500. This benefit comes as a dues paying member of SMART International.

**WEEKEND WORK ASSIGNMENTS:** Saturday and Sunday work assignments. Please remember that when performing work on a Saturday or Sunday the steward must report it to the hall, give each members name and obtain a form for signatures. Each member must sign the form along with the number of hours they worked. The completed form must be sent back to by hall by the end of the day on the following Monday. Weekend work assignments must be called or emailed into the hall **prior to 3:00 pm on Friday.**

**WORK ASSIGNMENTS: Everyone must obtain a work assignment prior to starting work.** If you fail to do so you could be written up on charges.

**LAY-OFFS:** All members must report to the Union Hall immediately upon lay-off, even if you only work one day. These are the By-Law rules for the Out-of-Work List. Your name will be removed from the list fourteen (14) days after receiving an assignment. It is very important to report to the union hall immediately after your layoff. Members get confused because the S.U.B. Fund allows you a period of up to seven (7) days to apply for S.U.B. benefits after lay-off.

**LAY-OFF SLIPS/TERMINATION NOTICES: Lay off slips must accompany all applications for sub pay.** Without lay off slips you cannot collect sub pay. It is the **member's responsibility** to make sure they get one from the contractor when laid off. Your application cannot be submitted without one. It is the contractor's responsibility to issue one in accordance with our contract.

**S.U.B. BENEFITS:** Report to the hall promptly upon layoff. You must complete a S.U.B. Application within seven (7) days from your layoff date or you will forfeit S.U.B. benefits. Lay-off slips must accompany the application to be eligible. Proof of UIA benefit payments must be submitted within 21 days of when you were paid in order to receive SUB benefits. Do not submit your sub applications directly to the fund office. Your application must be signed by the hall or you will not collect benefits.

**OUT-OF-WORK LIST:** You must be on the out-of-work list to collect S.U.B. benefits or SASMI. Members must re-register bi-annually: March 1 through March 20 and Sept. 1 through Sept. 20. If you fail to re-register you will be removed from the list.

**SHORT WORK WEEK SUB PAY:** If you work 16 hours or less in a week or have a short work week due to weather you may collect sub for that week but only if it is at the **beginning or the end of a layoff.** You may NOT collect if you are not laid off. You must complete a sub application at the hall, provide a pay stub for that week and the hall will submit it to the fund office. If you are not laid off and it is due to weather the company MUST provide written documentation that it was weather related.

Cougars, Michigan's 'ghost cat'

You may have read the stories on Facebook or on other social media platforms.

Tantalizing and captivating claims from across Michigan: cougars seen wandering backyards in the suburbs around Detroit, black panthers skulking through farm fields and attacks all over the state on pets and livestock.

But what's the truth about mountain lions in Michigan?

How many are there? Where are they? And how worried should we be?

Cougars, also called mountain lions or pumas, are native to Michigan and would have been found here prior to European colonization of the region. Early European settlers, however, saw the cat as a threat to them and their livestock, as well as a competitor for venison and other wild game.

Consequently, by the late 1800s, cougars were almost eliminated from the eastern United States, driven by these fears. Wholesale logging of the forests the cougars called home also played a role, as waves of settlement converted much of the state to farmland.

Many states and the federal government created bounties, money paid to people to kill cougars and other predators, with the goal of erasing them from the landscape. These efforts worked so well that cougars were eliminated from Michigan by the early 20th century.

While memories of these big cats persisted in communities across the state, trying to find physical evidence to support reported sightings proved to be a bit like chasing a ghost.

When evidence was collected at the scene of a reported cougar sighting, like photographs, the culprit was often found to be something other than a mountain lion.

These would-be cougars were actually animals as mundane as a large housecat seen from an

angle that made it appear much larger or as unusual and exotic as an escaped pet serval – a large wild cat from Africa that's definitely not legal to keep as a pet in Michigan.

As reported sightings became more common, the Michigan Department of Natural Resources created a "cougar team" in 2008 to review reports of cou-

gars and to try to verify them.

Brian Roell, a DNR wildlife biologist at Marquette, takes the mission of the cougar team very seriously.

"The team is made up of wildlife biologists for the DNR who have received specialized training in how to identify cougars from photos, as well as from tracks, scat and other physical evidence they may leave behind," Roell said. "It's important that we're able to identify these animals correctly, not just for conservation purposes but also so that residents can be informed about the wildlife living around them and take common-sense precautions."

Over the 13 years since the formation of the cougar team, its members have met weekly to review

reports with supporting evidence submitted to the DNR.

If the evidence appears to have come from a cougar, DNR staffers will follow up with a site visit. This helps the biologists verify that photos haven't been faked or reported from false locations. The visits also let the biologists measure trees and other objects to help estimate the size of animals in photos submitted with reports.

Sometimes, the team members even use a life-sized, cardboard cougar silhouette to try to recreate the photo to help arrive at a correct identification.

So far, their hard work has verified 65 cougar reports in Michigan.

"We don't think these are all different cougars," Roell said. "Many of these reports include photos from trail cameras, and it's very likely that the same cat is being spotted in different places as it moves through the forest."

What does this tell us about how many cougars are in Michigan?

"There's no evidence of a breeding population here – no signs of kittens in any verified report, and all of the animals where

we've been able to determine their sex have been male," said Kristie Sitar, DNR wildlife biologist at Newberry.

Sitar said some DNA studies have been conducted on the cougars found here, using evidence collected from verified reports or a cougar poached in Schoolcraft County several years ago.

This testing has shown the animals being reported in Michigan have traced back to a population found in South Dakota, Wyoming and Nebraska.

"These are likely young male cougars looking for areas far from home where they can find mates and establish their own territories, and they just keep moving when they don't find any female cougars," Sitar said.

Should you be worried about seeing a mountain lion near your home? All but one of the verified cougar sightings the team has reviewed have been from the Upper Peninsula. Chances of seeing one in the Lower Peninsula are extremely low.

Like with most wildlife, there are some simple preventative steps you can take to make your home less attractive to cougars.

Remove sources of food, shelter and safety. For cougars, this means not letting pets roam outside alone, providing shelter for livestock, not feeding wildlife,

removing landscaping that provides shrubby cover for animals to hide in near buildings and installing outside lighting with motion detectors.

If you encounter a cougar when you're outdoors, your best bet is to try to appear too dangerous to tangle with: don't turn your back on the animal, look as large as you can by standing tall and waving your arms, and talk loudly.

Never run from a cougar, though you can move away slowly. If you are attacked, fight back and never play dead. Remember that the likelihood that you'll ever see a cougar in Michigan is extremely low, and the likelihood of an attack is even lower.

"These cats are very rare in Michigan," said Pete Kailing, a DNR wildlife biologist in Paris. "Much of the data we've been able to gather so far is thanks to the willingness of Michiganders to share their photos and other evidence with us."

If you're interested in learning more about cougars in Michigan, Kailing suggests starting at Michigan.gov/Cougars, where you can find tips on how to tell if the animal you've seen is a cougar, how to report a cougar sighting and the current status on where cougars have been confirmed in Michigan.
